NOTICE OF PUBLIC WORKSHOP

In the Matter of a Proposed Amendment to the
Water Quality Control Plan for the Colorado River Basin Region
to Revise a Septic Tank Discharge Prohibition
in the Town of Yucca Valley

NOTICE IS HEREBY GIVEN that staff of the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) will hold a Public Workshop to discuss the Proposed Amendment to Revise the Yucca Valley Septic Tank Discharge Prohibition of the Water Quality Control Plan for the Colorado River Basin Region. The schedule for the Public Workshop on this matter is provided below.

In accordance with statutory requirements, notice of the proposed amendment and Regional Water Board public hearing to consider adoption of the amendment was previously published in several local newspapers and posted on the Regional Water Board's website on December 8, 2015 (Public Notice No. 7-15-42). The Notice provided a 45-day comment period from December 8, 2015, through January 22, 2016. Subsequently, a "Revised Notice of Public Hearing" was published advising the public that the location of the March 10, 2016 Regional Water Board meeting had been changed from the City of Brawley to the Town of Yucca Valley Community Center's Yucca Room.

The purpose of the Workshop is to provide affected stakeholders and other interested persons an additional opportunity to ask questions about and provide comments on the proposed amendment. During the Workshop, Regional Water Board staff will provide an overview of the key proposed changes to the Prohibition, be available to answer questions about the proposed changes, and take comments on the proposed amendment.
