NOTICE OF OPPORTUNITY TO COMMENT

**PROPOSED RESOLUTION OF VIOLATIONS
CONDITIONAL SETTLEMENT OFFER NO. R7-2018-0021 FOR
CITY OF COACHELLA AND THE COACHELLA SANITARY DISTRICT
RIVERSIDE COUNTY**

NOTICE IS HEREBY GIVEN THAT the California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public comment a proposed resolution of discharge limit violations subject to mandatory minimum penalties.

On May 7, 2018, the Assistant Executive Officer issued a Conditional Settlement Offer to the City of Coachella, Coachella Sanitary District (Discharger). The Conditional Settlement Offer provided the Discharger an opportunity to resolve effluent limit violations of Waste Discharge Requirements (WDR) Order No. R7-2010-0021 (NPDES No. CA0104493) without a formal enforcement proceeding.

On June 4, 2018, the Discharger accepted the Conditional Settlement Offer and signed the "Acceptance of Conditional Resolution and Waiver of Right to Hearing" (Acceptance and Waiver). Pursuant to federal regulations, the Colorado River Basin Water Board is releasing the Conditional Settlement Offer for public comment. If no comments are received within thirty (30) days and no new material facts become available, the Executive Officer will execute the Acceptance and Waiver as a stipulated Order assessing the uncontested mandatory minimum penalty amount pursuant to Water Code sections 13385 and/or 13385.1. If, however, significant comments are received in opposition to the Conditional Settlement Offer, the offer may be withdrawn.
