**NOTICE OF PUBLIC HEARING  
FOR  
SHORT TERM RENEWAL OF ORDER R7-2014-0046  
CONDITIONAL WAIVER OF WASTE DISCHARGE REQUIREMENTS  
FOR AGRICULTURAL WASTEWATER DISCHARGES OF WASTE FROM DRAIN OPERATION  
AND MAINTENANCE ACTIVITIES ORIGINATING WITHIN THE COACHELLA VALLEY  
TENTATIVE ORDER R7-2019-XXXX**

The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) has prepared tentative Order R7-2019-XXXX, *Short Term Renewal of Order R7-2014-0046, Conditional Waiver of Waste Discharge Requirements for Agricultural Wastewater Discharges and Discharges of Waste from Drain Operation and Maintenance Activities Originating Within the Coachella Valley* (Tentative Order).

Agricultural waste discharges in the Coachella Valley are currently regulated by Order R7-2014-0046, *Conditional Waiver of Waste Discharge Requirements for Agricultural Wastewater Discharges and Discharges of Waste from Drain Operation and Maintenance Activities Originating Within the Coachella Valley* (2014 Conditional Waiver). Colorado River Basin Water Board staff is developing general waste discharge requirements to replace the 2014 Conditional Waiver, but is not likely to be finished before the 2014 Conditional Order expires on June 26, 2019.

The Tentative Order renews the 2014 Conditional Waiver for a period of 12 months until June 26, 2020, but does not modify any other terms of the waiver.
