**NOTICE OF PUBLIC HEARING FOR  
NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT  
AND WASTE DISCHARGE REQUIREMENTS (WDRs)  
PROPOSED ORDER R7-2020-0010**

The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2020-0010 (Proposed Order), which will serve as an NPDES permit and WDRs for the City of Calipatria Wastewater Treatment Plant. The following discharger has applied for reissuance of the current NPDES permit, Order R7-2015-0005, under section 402 of the federal Clean Water Act NPDES permit program (33 U.S.C. § 1342):

Staff of the Colorado River Basin Water Board has prepared the Proposed Order for the above discharger containing effluent and receiving water limitations and special provisions in accordance with the federal Clean Water Act (33 U.S.C. § 1251 et seq.) and the Porter-Cologne Water Quality Control Act (Water Code, § 13000 et seq.). ## **BACKGROUND**

The City of Calipatria (Discharger) owns and operates a wastewater collection, treatment, and disposal system (Facility) and provides sewerage service to a population of approximately 8,000 located in the City of Calipatria, Calipatria State Prison, as well as unincorporated communities in Imperial County. The Facility has a treatment capacity of 1.73 million gallons per day (MGD) and consists of two raw wastewater lift stations, a rotating bar screen from the prison inflow, four-cell aerated lagoon system, and disinfection system.

Treated effluent from the aerated lagoons is chlorinated in a chlorine contact basin. The chlorinated effluent from the chlorine contact basin is then combined and dechlorinated with the addition of sodium bisulfite prior to discharge into "G" Drain, an irrigation canal located south of the Facility. Final effluent is discharged through Discharge Point 001 at Latitude 33° 8' 50.9" North and Longitude 115° 33' 10" West to the "G" Drain, a tributary to the Alamo River, a water of the United States.

## **SUBMISSION OF WRITTEN COMMENTS**

The Colorado River Basin Water Board will accept comments during a thirty (30) day public comment period, which begins **October 7, 2020** and ends **November 5, 2020**. Written comments on the Proposed Order must be received no later than 5:00 p.m., **November 5, 2020**. Comments received by this deadline will be included in the administrative record. If written comments to the Colorado River Basin Water Board are not timely submitted, however, the Board Chair may refuse to accept such evidence or admit it into the administrative record unless the commenter can demonstrate why he or she was unable to timely submit the evidence, that compliance with the deadline would create an unreasonable hardship, or that allowing the evidence would not prejudice any party or the Colorado River Basin Water Board. (Cal. Code Regs., tit. 23, § 648.4.)
