HEARING PROCEDURE

Affected stakeholders and other interested persons are invited to attend and express their views orally on this matter at the public hearing. The Regional Water Board requests that those persons wishing to speak at the hearing provide a copy of their oral comments in writing before or during the hearing to ensure accuracy of the record.

Those who wish to speak at the hearing will be asked to fill out a speaker request card and provide it to Regional Water Board staff. Comments from the public will be limited to three (3) minutes per person. Any person planning to make a presentation to the Regional Water Board that requires the use of visual aids (such as overheads, slides, or video projector) should contact the assigned staff person to make arrangements before the meeting date in order to avoid unnecessary delays during the meeting. Where speakers can be grouped by affiliation or interest, such groups will be expected to select a spokesperson and not be repetitive.
