**NOTICE OF PUBLIC HEARING

WASTE DISCHARGE REQUIREMENTS
PROPOSED ORDER R7-2020-0018**

The California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) has prepared proposed Order R7-2020-0018 (Proposed Order) for the California Department of Transportation, Cactus City Safety Rest Area Wastewater Treatment Facility (Facility) located east of Indio in Riverside County. The Regional Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the following date and time, **by video and teleconference only**:

As a result of the COVID-19 emergency and the Governor's Executive Orders to protect public health by limiting public gatherings and requiring social distancing, the June 24, 2020 Board meeting will occur solely via remote presence. SUBMISSION OF WRITTEN COMMENTS

The Regional Water Board will accept written comments regarding this Proposed Order during a 30-day public comment period, which begins **May 8, 2020** and ends **June 8, 2020**. Persons wishing to submit written comments on the Proposed Order are requested to do so as soon as possible, but no later than **June 8, 2020**.

HEARING PROCEDURE

Affected stakeholders and other interested persons are invited to attend and express their views orally on this matter at the public hearing. The Regional Water Board requests that those persons wishing to speak at the hearing provide a copy of their oral comments in writing before or during the hearing to ensure accuracy of the record.

Those who wish to speak at the hearing will be asked to fill out a speaker request card and provide it to Regional Water Board staff. Comments from the public will be limited to three (3) minutes per person. Any person planning to make a presentation to the Regional Water Board that requires the use of visual aids (such as overheads, slides, or video projector) should contact the assigned staff person to make arrangements before the meeting date in order to avoid unnecessary delays during the meeting. Where speakers can be grouped by affiliation or interest, such groups will be expected to select a spokesperson and not be repetitive.
