The California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) has prepared proposed Order R7-2022-0009 (Proposed Order) for Water Reclamation Plant No. 7 (Facility), owned and operated by Coachella Valley Water District, located in Indio, Riverside County. The Regional Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:
