# NOTICE OF PUBLIC HEARING FOR

### WASTE DISCHARGE REQUIREMENTS FOR DREDGED OR FILL DISCHARGES TO WATERS OF THE STATE PROPOSED ORDER R7-2021-0052

### ISSUED TO THE CALIFORNIA DEPARTMENT OF WATER RESOURCES -CLUBHOUSE, TULE WASH, AND BOMBAY BEACH WEST VEGETATION ENHANCEMENT AND DUST SUPPRESSION PROJECTS, IMPERIAL COUNTY

The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2021-0052 (Proposed Order) to California Department of Water Resources (Permittee) for the Clubhouse, Tule Wash, and Bombay Beach West Vegetation Enhancement and Dust Suppression Projects (Project). The purpose of the Project is to enhance vegetation growth and suppress dust emissions in three areas on the shores of the Salton Sea. The sea's continuing decline in elevation and resulting exposure of lakebed are negatively impacting surrounding communities and reducing remaining habitat for fish and wildlife. The Clubhouse and Tule Wash Project areas are located on the western shore of the Salton Sea, and the Bombay Beach West Project area is located on the eastern shore. All Project areas are in Imperial County on land managed by the U.S. Bureau of Reclamation.

The Colorado River Basin Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:
