The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2020-0020 (Proposed Order) for Southern California Gas Company (SoCalGas or Permittee) for the Line 4000 Phase Remediation Digs Project (Project). The Project is located on Bureau of Land Management (BLM) land between Ord Mountain and Highway 18, all in unincorporated San Bernardino County, California. This Project includes inspection and replacement of two sections of natural gas pipeline to promote the continued safety and integrity of Line 4000. The Project is expected to impact waters of the state.

The Colorado River Basin Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:

Time: 9:00 a.m.  
Location: Virtual Meeting via Zoom Video and Teleconference

As a result of the COVID-19 emergency and the Governor's Executive Orders to protect public health by limiting public gatherings and requiring social distancing, the Board meeting will occur solely via remote presence.

Interested persons are invited to attend and express their views orally on this matter at the public hearing. The Colorado River Basin Water Board requests that those persons wishing to speak at the hearing provide a copy of their oral comments in writing before or during the hearing to ensure accuracy of the record.
