NOTICE OF PUBLIC HEARING FOR WASTE DISCHARGE REQUIREMENTS

WASTE DISCHARGE REQUIREMENTS FOR IMPERIAL COUNTY DEPARTMENT OF PUBLIC WORKS HOT SPA WASTE MANAGEMENT FACILITY PROPOSED ORDER R7-2021-0026

The California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) has prepared proposed Order R7-2021-0026 (Proposed Order) for the Hot Spa Waste Management Facility (Facility), owned and operated by Imperial County Department of Public Works (Discharger), located near the town of Niland at the south eastern end of the Salton Sea. The Facility includes a Class III landfill Waste Management Unit (WMU), formerly used for the disposal of municipal, nonhazardous solid waste. All disposal areas stopped receiving waste in 2018. The Proposed Order updates the waste discharge requirements to comply with current laws and regulations and includes requirements for closure and post-closure maintenance of the WMU.

The Regional Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:

The Regional Water Board requests that those persons wishing to speak at the hearing provide a copy of their oral comments in writing before or during the hearing to ensure accuracy of the record.

Those who wish to speak at the hearing will be asked to fill out a speaker request card and provide it to Regional Water Board staff. Comments from the public will be limited to three (3) minutes per person. Any person planning to make a presentation to the Regional Water Board that requires the use of visual aids (such as overheads, slides, or video projector) should contact the assigned staff person to make arrangements before the meeting date in order to avoid unnecessary delays during the meeting. Where speakers can be grouped by affiliation or interest, such groups will be expected to select a spokesperson and not be repetitive.
