The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2020-0036 to the Southern California Gas Company for the Pipeline Safety Enhancement Plan L1030/2001W P2 And 2001E P2 Hydrotests Project (Project). The Project is scheduled to occur at several worksite locations beginning 10 miles west of Blythe, California, and ending 16 miles east of Coachella, California. The Project will roughly follow the alignment of Interstate 10 and all worksites are in Riverside County, California. The Project is expected to impact waters of the state.

The Colorado River Basin Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:
