**NOTICE OF PUBLIC HEARING
FOR
PROPOSED ORDER R7-2019-0019-02
AMENDMENT TO CEASE AND DESIST ORDER R7-2019-0019**

The California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) has prepared proposed Amended Cease and Desist Order R7-2019-0019-02 (Proposed Order) for the Palm Springs Aerial Tramway, Mountain Station Wastewater Treatment Plan located in Riverside County, owned and operated by the Mt. San Jacinto Winter Park Authority. The Regional Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:
