The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2022-0016(Proposed Order) to the Seefried Industrial Properties (Permittee) for the Project Viento (Project). The Project is located north of Interstate 10, east and south of State Route 62, and west of the Little San Bernardino Mountains in the City of Desert Hot Springs, Riverside County, California. The Project is expected to impact waters of the state.
