**NOTICE OF PUBLIC HEARING

RESCISSION OF WASTE DISCHARGE REQUIREMENTS

The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2022-0019. BACKGROUND

Waste Discharge Requirements (Order) were issued at the request of the Southern California Gas Company (Permittee) for the Line 4000 Phase 1 Remediation Digs Project (Project). The Permittee submitted a Request for Notice of Completion of Discharges Letter with a report that included a summary of work and post-construction restoration activities completed as described in the WDR. All work areas were restored to pre-construction contours and stabilized upon the Project completion date of November 19, 2021.
