**TENTATIVE SETTLEMENT AGREEMENT AND STIPULATION FOR ENTRY OF
ADMINISTRATIVE CIVIL LIABILITY ORDER R7-2022-0045**

SUBMISSION OF WRITTEN COMMENTS

The Colorado River Basin Water Board will accept comments on the Tentative Order during a 30-day public comment period ending on **November 21, 2022**. All written comments must be received no later than **5:00 pm**.

At the conclusion of the public comment period, the Executive Officer will consider the Tentative Order for adoption pursuant to the Colorado River Basin Water Board's delegation of authority. Alternatively, the Executive Officer may decide that the Tentative Order should be presented to the Colorado River Basin Water Board for its consideration and adoption. If the matter is going to be presented to the Colorado River Basin Water Board additional information about the time and the place of the Board Meeting will be provided.

If significant public comments are received, the Colorado River Basin Water Board Prosecution Team and Mission Springs Water District (together, Parties) retain the right to withdraw the settlement agreement.
