## NOTICE OF OPPORTUNITY TO COMMENT

### PROPOSED RESOLUTION OF VIOLATIONS TENTATIVE SETTLEMENT AGREEMENT AND STIPULATION FOR ENTRY OF ADMINISTRATIVE CIVIL LIABILITY ORDER NO. R7-2025-0027 FOR

#### SEELEY COUNTY WATER DISTRICT SEELEY COUNTY WATER DISTRICT WASTEWATER TREATMENT PLANT IMPERIAL COUNTY

**NOTICE IS HEREBY GIVEN THAT** the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) is releasing for public comment a proposed resolution of discharge effluent limitation violations subject to mandatory minimum penalties pursuant to California Water Code (Water Code) section 13385, subdivisions (h) and/or (i).

Seeley County Water District (Discharger) and the Regional Water Board Prosecution Team (collectively, Parties) have entered into a tentative settlement to resolve alleged violations without formal administrative proceedings and have agreed to the imposition of **\$183,000** (one hundred eighty-three thousand dollars) in mandatory minimum penalties. The alleged violations occurred at the Discharger's municipal wastewater treatment plant in Seeley, Imperial County, which the Colorado River Basin Water Board regulates under Waste Discharge Requirements Order No. R7-2023-0003.
