Project Description:

The Southern California Gas Company (SoCalGas) is proposing the Shaver Summit Pressure Limiting Station Redesign Project (Project) to modify the existing Shaver Summit Pressure Limiting Station (facility) to meet current standards associated with corrosion and cathodic protection. The Project involves the installation of two new pressure limiting device stations associated with high pressure natural gas transmission pipelines, excavation and daylighting of existing high pressure gas lines, installation of pipeline crossover sections and mainline valves, installation of new anode wells, removal of release valves, and backfilling of excavated areas and exposed high pressure gas line infrastructure. The Project will require an expansion of the existing facility, approximately 110 feet by 85 feet, and an expanded easement which will be approximately 390 feet by 270 feet following construction activities.

The planned facility expansion will all be carried out within the recently expanded SoCalGas right-of-way (ROW). Expansion will require the rerouting of two ephemeral drainages around the new facility footprint and will permanently redevelop approximately 170 feet of the existing dirt access road. A new security fence will be built around the expanded facility. An approximately 2.8-acre temporary laydown yard and staging area will be constructed about 4,000 feet east of the facility, and will be used for fabrication, materials storage, and equipment storage during construction. Temporarily impacted areas will be restored as necessary.
