I. Order

This Clean Water Act (CWA) section 401 Water Quality Certification action and Order (Order) is issued by the California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) at the request of Union Pacific Railroad Company (Permittee or UPRR) for the Yuma Sub MP 726.08 Bridge Replacement Project (Project). This Order is for the purpose described in the application submitted by the Permittee. The application was received on November 30, 2018. The application was deemed complete on January 4, 2019.

II. Public Notice

The Colorado River Basin Water Board provided public notice (12-05-2018) of the application pursuant to California Code of Regulations, title 23, section 3858 from December 5, 2018 to December 26, 2018. The Colorado River Basin Water Board did not receive any comments during the comment period.

III. Project Purpose

The purpose of the Project is to replace the existing trestle bridge, which spans a desert dry wash tributary to the Colorado River, with a new bridge that conforms to current safety standards and is designed to withstand 50-year and 100-year flood events. The Project will also remove sediment that has accumulated in the bridge openings and that has reduced drainage capacity.

IV. Project Description

Existing Facilities

The existing bridge contains two segments (Segment A and Segment B):

Segment A: A 76-foot long, 6-span section consisting of timber stringers over a concrete abutment and five concrete piers. The stringers are 14 by 14 inches with a 3-inch timber deck, steel cable handrail, and timber ties. The ballast retainer is 23-inch high timber and 22-inch high concrete. Deck width for this segment is 15 feet 10 inches. This segment's construction date is on record as 1906.

Segment B: A 98-foot long, 8-span section consisting of a steel beam span over a concrete abutment and nine concrete piers with 11 beams. The deck floor is 3-inch thick timber with steel cable handrail, and the ballast retainer is 12-inch high timber. Deck width for this segment is 16 feet. Similar to Segment A, Segment B also has a construction date of 1906.

Proposed Project

The Project will replace the existing bridge with 204-foot long, 16-span pre-stressed concrete slabs (PCS) with timber ties. The proposed bridge will be supported by 17 bent rows with 6 steel piles per bent row. Riprap will be added to all bridge supports above and below the Ordinary High Water Mark (OHWM) of Araz Wash.

The Project will be built in two phases to accommodate the separate tracks that each existing bridge supports. Phase 1 will accommodate main track no. 2 and phase 2 will accommodate main track no. 1. Both phases of bridge construction will be built using an off-track crane. All construction traffic will utilize an existing access road within the railroad's right-of-way (ROW) and staging areas will take place on already-disturbed land within the ROW. Prior to construction, there will also be maintenance dredging of the dry streambed under the existing bridge.

V. Project Location

The Project is located in an area 5 miles northwest of Yuma, AZ in Imperial County, California at the existing trestle bridge located at Mile Post 726.08 (32° 45' 1.303" N, 114° 42' 33.940" W). Maps showing the Project location are found in Attachment A of this Order.

VI. Project Impact and Receiving Waters Information

The Project is located within the jurisdiction of the Colorado River Basin Water Board. Receiving waters and groundwater potentially impacted by this Project are protected in accordance with the applicable water quality control plan (Basin Plan) for the region and other plans and policies, accessible online at: http://www.waterboards.ca.gov/plans-policies/. The Basin Plan includes water quality standards, which consist of existing and potential beneficial uses of waters of the United States/state, water quality objectives to protect those uses, and the state and federal anti-degradation policies.

Project impact and receiving waters information can be found in Attachment B. The Colorado River is the receiving water through its tributary – Araz Wash.

Table 1 of Attachment B shows the receiving waters and beneficial uses of waters of the U.S. impacted by the Project. Individual impact location and quantity is shown in Table 2 of Attachment B.

VII. Description of Direct Impacts to Waters of the U.S.

The Project will be constructed within Araz Wash in the UPRR ROW. Temporary impacts below the OHWM of the Araz Wash will result from the construction of a concrete/slurry slab placed to drive the steel piles and a temporary stream crossing to reach the southwestern staging area. Maintenance dredging of the dry streambed will also take place under the existing bridge prior to construction. To the extent possible, all areas of temporary impact will be returned to their preconstruction condition upon completion of construction.

Permanent impacts to the dry wash include the installation of 102 piles for the new bridges and the placement of riprap around the abutments for scour control.

Runoff from the Project location runs through Araz Wash, which flows directly to the Colorado River.

Total Project fill/excavation quantities for all impacts are summarized in Table 1. Permanent impacts are categorized as those resulting in a physical loss in area and also those degrading only ecological conditions.

VIII. Compensatory Mitigation

There are minimal permanent project impacts; therefore, no compensatory mitigation is required for permanent impacts.

IX. California Environmental Quality Act (CEQA)

The Colorado River Basin Water Board has determined that the Project is exempt from review under CEQA pursuant to California Code of Regulations, title 14, section 15061. Specifically, the issuance of this Order and the Project described herein meet the exemption criteria under California Code of Regulations, title 14 sections 15302 (Replacement or Reconstruction), 15301 (Existing Facilities), and 15304 (Minor Alternations to Land). Additionally, the Colorado River Basin Water Board concludes that no exceptions to the CEQA exemptions listed above apply to the activities approved by this Order.

Pursuant to CEQA, the Colorado River Basin Water Board has made Findings of Facts (Findings) which support the issuance of this Order, which are included in Attachment C.

X. Petitions for Reconsideration

Any person aggrieved by this action may petition the State Water Resources Control Board (State Water Board) to reconsider this Order in accordance with California Code of Regulations, title 23, section 3867. A petition for reconsideration must be submitted in writing and received within 30 calendar days of the issuance of this Order.

XI. Fees Received

An application fee of \$1,638 was received on November 30, 2018. The total fee amount was determined as required by California Code of Regulations, title 23, sections 3833(b)(3) and 2200(a)(3), and was calculated as Category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator and totaled \$4,492.

The remaining \$2,854 was received on January 8, 2019.

XII. Conditions

The Colorado River Basin Water Board has independently reviewed the record of the Project to analyze impacts to water quality and designated beneficial uses within the watersheds of the Project. In accordance with this Order, the Permittee may proceed with the Project under the following terms and conditions:

A. Authorization

- 1. Impacts to waters of the U.S. shall not exceed quantities shown in Table 1.
- 2. Work shall only be performed under "no flow" conditions in the dry wash to preclude potential impacts to water quality.

B. Reporting and Notification Requirements

The following section details the reporting and notification types and timing of submittals. Requirements for the content of these reporting and notification types are detailed in Attachment E, including specifications for photo and map documentation during the Project. Written reports and notifications must be submitted using the Reporting and Notification Cover Sheet located in Attachment E, which must be signed by the Permittee or an authorized representative.

1. Project Reporting

- **a. Monthly Reporting:** The Permittee must submit a Monthly Report to the Colorado River Basin Water Board on the 15th day of each month for the duration of the construction phase (approximately 40 working days). Monthly reporting shall continue until the Colorado River Basin Water Board issues a Notice of Project Complete Letter to the Permittee.
- b. Annual Reporting: The Permittee must submit an Annual Report including activities conducted for the previous fiscal year (July 1 June 30) to the Colorado River Basin Water Board on the 1st of September. Annual Reports must be submitted even if Project construction has not begun. Annual reporting shall continue until a Notice of Project Complete Letter is issued to the Permittee by the Colorado River Basin Water Board.
- c. Other Reporting: If pollutants are observed in surface water, the Permittee shall submit a report to the Colorado River Basin Water Board within 30-days after encountering the pollutants and describe actions taken to correct the problem and provide photographic documentation that supports the information in the report.

If repairs are required, the Permittee shall take pictures of the area where work needs to take place, documenting the before and after conditions of the area; and shall maintain a daily log for each site where work is taking place pursuant to this Order, while the Permittee conducts its repair activities. The log shall:

- Provide a general description of the repair work;
- Specify the date and daily starting and ending time for the repair work:

 Note key weather conditions (e.g., temperature, wind speed and direction, precipitation, if any);

 Include notes from visual observations regarding the presence/absence of construction debris/trash (e.g., discarded filter fiber) and used oil (e.g., oil that leaks from construction equipment) in the area where the work has taken place.

Within 30 days following completion of all repair work, the Permittee shall submit to the Colorado River Basin Water Board a summary report of the key daily log entries. The summary report shall include the above-mentioned before and after pictures of the conditions of the area and shall be signed by the Permittee's Project Manager.

2. Project Status Notifications

- a. Commencement of Construction: The Permittee shall submit a Commencement of Construction Report at least seven (7) days prior to start of initial ground disturbance activities.
- b. Request for Notice of Completion of Discharges Letter: The Permittee shall submit a Request for Notice of Completion of Discharges Letter following completion of active Project construction activities, including any required restoration and permittee-responsible mitigation. This request shall be submitted to the Colorado River Basin Water Board staff within thirty (30) days following completion of all Project construction activities. Upon acceptance of the request, Colorado River Basin Water Board staff shall issue a Notice of Completion of Discharges Letter to the Permittee, which will end the active discharge period and associated annual fees.
- c. Request for Notice of Project Complete Letter: The Permittee shall submit a Request for Notice of Project Complete Letter when construction and/or any post-construction monitoring is complete,³ and no further Project activities will occur. This request shall be submitted to Colorado River Basin Water Board staff within thirty (30) days following completion of all Project activities. Upon approval of the request, the Colorado River Basin Water Board staff shall issue a Notice of Project Complete Letter to the Permittee, which will end the post-discharge monitoring period and associated annual fees.
- Conditional Notifications and Reports: The following notifications and reports are required as appropriate.
 - a. Accidental Discharges of Hazardous Materials: Following an accidental discharge of a reportable quantity of a hazardous material, sewage, or an unknown material, the following applies (Wat. Code, § 13271):

- i. As soon as (A) Permittee has knowledge of the discharge or noncompliance, (B) notification is possible, and (C) notification can be provided without substantially impeding cleanup or other emergency measures then:
 - first call 911 (to notify the local response agency)
 - then call Office of Emergency Services (OES) State Warning Center at: (800) 852-7550 or (916) 845-8911
 - Lastly follow the required OES procedures as set forth in: http://www.caloes.ca.gov/FireRescueSite/Documents/CalOES-Spill Booklet Feb2014 FINAL BW Acc.pdf
- ii. Following notification to OES, the Permittee shall notify the Colorado River Basin Water Board, as soon as practicable (ideally within 24 hours). Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
- **iii.** Within five (5) working days of notification to the Colorado River Basin Water Board, the Permittee must submit an Accidental Discharge of Hazardous Material Report.
- b. Violation of Compliance with Water Quality Standards: The Permittee shall notify the Colorado River Basin Water Board of any event causing a violation of compliance with water quality standards. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
 - i. Examples of noncompliance events include: lack of storm water treatment following a rain event, discharges causing a visible plume in a water of the state, and water contact with uncured concrete.
 - ii. This notification must be followed within three (3) working days by submission of a Violation of Compliance with Water Quality Standards Report.

c. In-Water Work:

- i. The Permittee shall notify the Colorado River Basin Water Board at least fortyeight (48) hours prior to initiating work in water or stream diversions. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
- ii. Within three (3) working days following completion of work in water or stream diversions, an In-Water Work/Diversions Water Quality Monitoring Report must be submitted to Colorado River Basin Water Board staff.
- d. Modifications to Project: Project modifications may require an amendment of this Order. The Permittee shall give advance notice to Colorado River Basin Water Board staff if Project implementation as described in the application materials is altered in any way or by the imposition of subsequent permit conditions by any local, state or federal regulatory authority by submitting a Modifications to Project Report. The Permittee shall

inform Colorado River Basin Water Board staff of any Project modifications that will interfere with the Permittee's compliance with this Order.

- e. Transfer of Property Ownership: This Order is not transferable in its entirety or in part to any person or organization except after notice to the Colorado River Basin Water Board in accordance with the following terms:
 - i. The Permittee must notify the Colorado River Basin Water Board of any change in ownership or interest in ownership of the Project area by submitting a Transfer of Property Ownership Report. The Permittee and purchaser must sign and date the notification and provide such notification to the Colorado River Basin Water Board at least 10 days prior to the transfer of ownership.
 - Until such time as this Order has been modified to name the purchaser as the permittee, the Permittee shall continue to be responsible for all requirements set forth in this Order.
- f. Transfer of Long-Term BMP Maintenance: If maintenance responsibility for post-construction BMPs is legally transferred, the Permittee must submit to the Colorado River Basin Water Board a copy of such documentation and must provide the transferee with a copy of a long-term BMP maintenance plan that complies with manufacturer or designer specifications. The Permittee must provide such notification to the Colorado River Basin Water Board with a Transfer of Long-Term BMP Maintenance Report at least 10 days prior to the transfer of BMP maintenance responsibility.

C. Water Quality Monitoring

- 1. General: If surface water is present, continuous visual surface water monitoring shall be conducted to detect accidental discharge of construction related pollutants (e.g. oil and grease, turbidity plume, or uncured concrete).
- 2. Accidental Discharges/Noncompliance: Upon occurrence of an accidental discharge of hazardous materials or a violation of compliance with a water quality standard, Colorado River Basin Water Board staff may require water quality monitoring based on the discharge constituents and/or related water quality objectives and beneficial uses.
- 3. In-Water Work or Diversions: For projects involving planned work in water or stream diversions, a water quality monitoring plan shall be submitted to Colorado River Basin Water Board staff for acceptance at least 30 days in advance of any discharge to the affected water body. Water quality monitoring shall be conducted in accordance with the approved plan.

Sampling shall be conducted in accordance with Table 2 sampling parameters.⁵

4. Post-Construction: The Permittee shall visually inspect the Project site during the rainy season for five (5) years to ensure excessive erosion, stream instability, or other water quality pollution is not occurring in or downstream of the Project site. If water quality pollution is occurring, the Permittee shall contact the Colorado River Basin Water Board staff member overseeing the Project within three (3) working days. The Colorado River Basin Water Board may require the submission of a Violation of Compliance with Water Quality Standards Report. Additional permits may be required to carry out any necessary site remediation.

D. Standard

- 1. This Order is subject to modification or revocation upon administrative or judicial review, including review and amendment pursuant to Water Code section 13330 and California Code of Regulations, title 23, chapter 28, article 6 commencing with sections 3867-3869, inclusive. Additionally, the Colorado River Basin Water Board reserves the right to suspend, cancel, or modify and reissue this Order, after providing notice to the Permittee, if the Colorado River Basin Water Board determines that: the Project fails to comply with any of the conditions of this Order; there is a change in any condition that requires either a temporary or permanent reduction or elimination of the authorized discharge; or, when necessary to implement any new or revised water quality standards and implementation plans adopted or approved pursuant to the Porter-Cologne Water Quality Control Act (Wat. Code, § 13000 et seq.) or federal Clean Water Act section 303 (33 U.S.C. § 1313).
- 2. This Order is not intended and shall not be construed to apply to any activity involving a hydroelectric facility requiring a Federal Energy Regulatory Commission (FERC) license or an amendment to a FERC license, unless the pertinent certification application was filed pursuant to subsection 3855(b) of chapter 28, title 23 of the California Code of Regulations, and that application specifically identified that a FERC license or amendment to a FERC license for a hydroelectric facility was being sought.
- 3. This Order is conditioned upon total payment of any fee required under title 23 of the California Code of Regulations and owed by the Permittee.
- 4. In the event of any violation or threatened violation of the conditions of this Order, the violation or threatened violation shall be subject to any remedies, penalties, process, or

For purposes of Clean Water Act, section 401(d), the applicability of any state law authorizing remedies, penalties, processes, or sanctions for the violation or threatened violation constitutes a limitation necessary to assure compliance with the water quality standards and other pertinent requirements incorporated into this Order.

E. General Compliance

- Failure to comply with any condition of this Order shall constitute a violation of the Porter-Cologne Water Quality Control Act and the Clean Water Act. The Permittee and/or discharger may then be subject to administrative and/or civil liability pursuant to Water Code section 13385.
- 2. Permitted actions must not cause a violation of any applicable water quality standards, including impairment of designated beneficial uses for receiving waters as adopted in the Basin Plans by any applicable Colorado River Basin Water Board or any applicable State Water Board (collectively, Water Boards) water quality control plan or policy. The source of any such discharge must be eliminated as soon as practicable.
- 3. In response to a suspected violation of any condition of this Order, the Colorado River Basin Water Board may require the holder of this Order to furnish, under penalty of perjury, any technical or monitoring reports the Water Boards deem appropriate, provided that the burden, including costs, of the reports shall bear a reasonable relationship to the need for the reports and the benefits to be obtained from the reports. The additional monitoring requirements ensure that permitted discharges and activities comport with any applicable effluent limitations, water quality standards, and/or other appropriate requirement of state law.
- 4. The Permittee must, at all times, fully comply with engineering plans, specifications, and technical reports submitted to support this Order; and all subsequent submittals required as part of this Order. The conditions within this Order and Attachments supersede conflicting provisions within Permittee submittals.
- 5. This Order and all of its conditions contained herein continue to have full force and effect regardless of the expiration or revocation of any federal license or permit issued for the Project. For purposes of Clean Water Act, section 401(d), this condition constitutes a limitation necessary to assure compliance with the water quality standards and other pertinent requirements of state law.
- Construction General Permit Requirement: The Permittee shall maintain compliance with conditions described in, and required by, NPDES General Permit for Storm Water Discharges Associated with Construction and Land Disturbance Activities (Order No. 2009-0009-DWQ; NPDES No. CAS000002).
- 7. The Permittee shall submit to the Colorado River Basin Water Board a signed copy of the California Department of Fish and Wildlife's Lake and Streambed Alteration Agreement for the Project prior to any discharge of wastes to waters of the U.S./state.

F. Administrative

- Signatory requirements for all document submittals required by this Order are presented in Attachment D of this Order.
- 2. This Order does not authorize any act which results in the taking of a threatened, endangered or candidate species or any act, which is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish & G. Code, §§ 2050-2097) or the federal Endangered Species Act (16 U.S.C. §§ 1531-1544). If a "take" will result from any act authorized under this Order held by the Permittee, the Permittee must obtain authorization for the take prior to any construction or operation of the portion of the Project that may result in a take. The Permittee is responsible for meeting all requirements of the applicable endangered species act for the Project authorized under this Order.
- 3. The Permittee shall grant Colorado River Basin Water Board staff or an authorized representative (including an authorized contractor acting as a Water Board representative), upon presentation of credentials and other documents as may be required by law, permission to:
 - **a.** Enter upon the Project or compensatory mitigation site(s) premises where a regulated facility or activity is located or conducted, or where records are kept.
 - **b.** Have access to and copy any records that are kept and are relevant to the Project or the requirements of this Order.
 - **c.** Inspect any facilities, equipment (including monitoring and control equipment), practices, or operations regulated or required under this Order.
 - d. Sample or monitor for the purposes of assuring Order compliance.
- 4. A copy of this Order shall be provided to any consultants, contractors, and subcontractors working on the Project. Copies of this Order shall remain at the Project site for the duration of this Order. The Permittee shall be responsible for work conducted by its consultants, contractors, and any subcontractors.
- 5. A copy of this Order must be available at the Project site(s) during construction for review by site personnel and agencies. All personnel performing work on the Project shall be familiar with the content of this Order and its posted location at the Project site.

G. Construction

Good Site Management "Housekeeping"

- 1. The Permittee shall follow good site management "housekeeping" and implement erosion control, sediment control, and other construction-related best management practices depicted in the Table 3 below.
- 2. A qualified biological monitor shall be on site during all ground-disturbing activities (work area preparation, grading, clearing, grubbing, trenching, construction, and decommissioning activities) to prevent impacts to special-status species and other biological resources, as well as document and report any construction-related incidences.

- 3. The area of vegetation and soil disturbance shall be restricted to the smallest extent possible.
- **4.** After completing construction activities, any disturbed areas shall be restored to pre-existing contours and conditions to the extent feasible.

Hazardous Materials

- 5. No toxic and/or hazardous materials shall be stored near or within wash/drainage areas. To the extent practicable, these materials shall be stored offsite and placed in appropriate secondary containment.
- 6. Spoil sites shall not be located where spoil could be washed back into the stream channel or where spoil covers aquatic or riparian vegetation. Any materials placed in seasonally dry portions of the drainage areas that could be washed downstream or could be harmful to aquatic life shall be removed from the streambed prior to inundation by high flows.
- 7. No fueling or maintenance of equipment or vehicles shall occur adjacent or within the wash/drainage areas.

Stormwater Management

- 8. Work shall not be conducted during rain events.
- 9. The Permittee shall develop and implement a Stormwater Pollution Prevention Plan (SWPPP) that complies with the requirements of the State Water Board's Construction General Permit.

Roads

10. Work and staging areas and temporary access routes shall be sized, located, and flagged to limit potential impacts to natural areas. Previously-disturbed areas shall be used to the extent feasible.

H. Mitigation for Temporary Impacts

The Permittee shall restore all areas of temporary impacts to waters of the U.S. and all Project site upland areas of temporary disturbance which could result in a discharge of waters of the U.S.

XIII. Water Quality Certification

I hereby issue the Order for Yuma Sub MP 726.08 Bridge Replacement Project, WDID No. 7B133042001, certifying that as long as all of the conditions listed in this Order are met, any discharge from the referenced Project will comply with the applicable provisions of Clean Water Act sections 301 (Effluent Limitations), 302 (Water Quality Related Effluent Limitations), 303 (Water Quality Standards and Implementation Plans), 306 (National Standards of Performance), and 307 (Toxic and Pretreatment Effluent Standards).

Except insofar as may be modified by any preceding conditions, all Order actions are contingent on: (a) the discharge being limited and all proposed mitigation being completed in strict compliance with the conditions of this Order and the attachments to this Order; and, (b) compliance with all applicable requirements of statewide water quality control plans and policies and the Colorado River Basin Water Board's water quality control plan and policies.

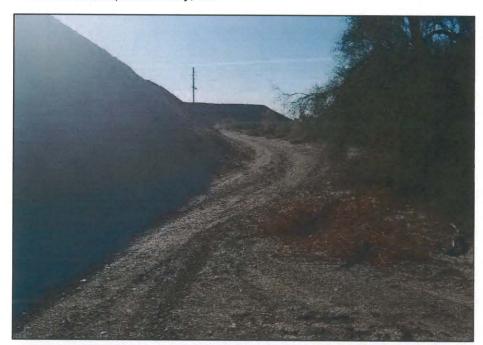

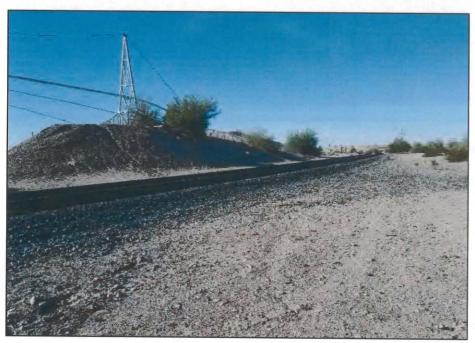

A. Introduction

The Colorado River Basin Water Board has determined that the Project is exempt from review under CEQA pursuant to California Code of Regulations, title 14, section 15061. Specifically, the issuance of this Order and the Project described herein meet the categorical exemption criteria under California Code of Regulations, title 14, section 15302 (Replacement or Reconstruction), section 15301 (Existing Facilities) and section 15304 (Minor Alterations to Land).

B. Findings

1. Applicable Categorical Exemptions

Under title 14, section 15302 (Replacement or Reconstruction) of the California Code of Regulations, there is a "Class 2" categorical exemption where the proposed project "consists of replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced" including "(b) [r]eplacement of a commercial structure with a new structure of substantially the same size, purpose, and capacity."

Additionally, section 15301 (Existing Facilities) contains a "Class 1" CEQA exemption where the project "consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination."

Finally, section 15304 (Minor Alternations to Land) contains a "Class 4" exemption where the project "consists of minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees except for forestry and agricultural purposes," including but not limited to "[m]aintenance dredging where the spoil is deposited in a spoil area authorized by all applicable state and federal regulatory agencies" and "[m]inor temporary use of land having negligible or no permanent effects on the environment."

The Project falls within the above exemptions found in sections 15302, 15301, and 15304. UPRR proposes to replace the existing trestle bridge over Araz Wash with a new bridge that will be of substantially the same size, purpose, and capacity. The replacement bridge will be 204-foot long, 16-span pre-stressed concrete slab girder with timber ties. The bridge will be supported by 17 bent rows with 6 steel piles per bent row and riprap will be placed around the supports. There will be certain temporary construction impacts to land; however, all construction traffic will utilize an existing access road and staging areas will take place on already-disturbed land within the UPRR right-of-way (ROW). Maintenance dredging of the dry streambed will also take place under the existing bridge.

2. No Exceptions to the Categorical Exemptions Apply

There is no substantial evidence that any exceptions to the CEQA categorical exemptions

listed above apply. Analysis of the relevant exceptions pursuant to section 15300.2 of the State CEQA Guidelines are as follows:

- a) Location. Classes 3, 4, 5, 6, and 11 are qualified by consideration of where the project is to be located a project that is ordinarily insignificant in its impact on the environment may in a particularly sensitive environment be significant. Therefore, these classes are considered to apply in all instances, except where the project may impact on an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies.
 - The Project does not impact an environmental resource of hazardous or critical concern that is designated, precisely mapped, and officially adopted by a federal, state, or local agency.
- b) Cumulative Impact. All exemptions for these classes are inapplicable when the cumulative impact of successive projects of the same type in the same place, over time is significant.
 - No significant cumulative impacts over time are anticipated. No similar projects have been previously conducted in the area within the last 5 years, nor are there any known similar projects planned for the next 5 years.
- c) Significant Effect. A categorical exemption shall not be used for an activity where there is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.
 - There are no "unusual circumstances" that would create a reasonable possibility of significant environmental impacts. The Project is being conducted near established railroad bridges that have been in continuous use. All construction will be performed under "no flow" conditions in the dry wash to preclude potential impacts to water quality. Best Management Practices (BMPs) will be used that are appropriate for this type of project activity.
- d) Scenic Highway. A categorical exemption shall not be used for a project which may result in damage to scenic resources, including but not limited to trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway.
 - The Project does not occur along a designated state scenic highway.
- e) Hazardous Waste Sites. A categorical exemption shall not be used for a project located on a site which is included on any list compiled pursuant to Section 65962.5 of Government Code.
 - The Project site is located along an existing railway and is not included on any list compiled pursuant to section 65962.5 of the Government Code.
- f) Historical Resources. A categorical exemption shall not be used for a project which may cause a substantial adverse change in the significance of a historical resource.
 - There is no anticipated substantial adverse change in the significance of a historical resource. UPRR contracted Arcadis U.S., Inc. to conduct searches of various historical

resource databases, retained a qualified archaeologist to complete a cultural resource review of the Project area, and conducted a pedestrian survey. No cultural resources of significance were identified. Both segments of the existing bridge were determined to be ineligible for the National Register of Historic Places.

C. Determination

The issuance of this Order and the activities described herein meet the exemption criteria under California Code of Regulations, title 14, section 15302 (Replacement or Reconstruction), section 15301 (Existing Facilities) and section 15304 (Minor Alterations to Land).

The Colorado River Basin Water Board concludes that no exceptions to the CEQA exemptions listed above apply to the activities approved by this Order.

The Colorado River Basin Water Board shall file a Notice of Exemption with the State Clearinghouse within five (5) working days from the issuance of this Order. (Cal. Code Regs., tit. 14, § 15062.)



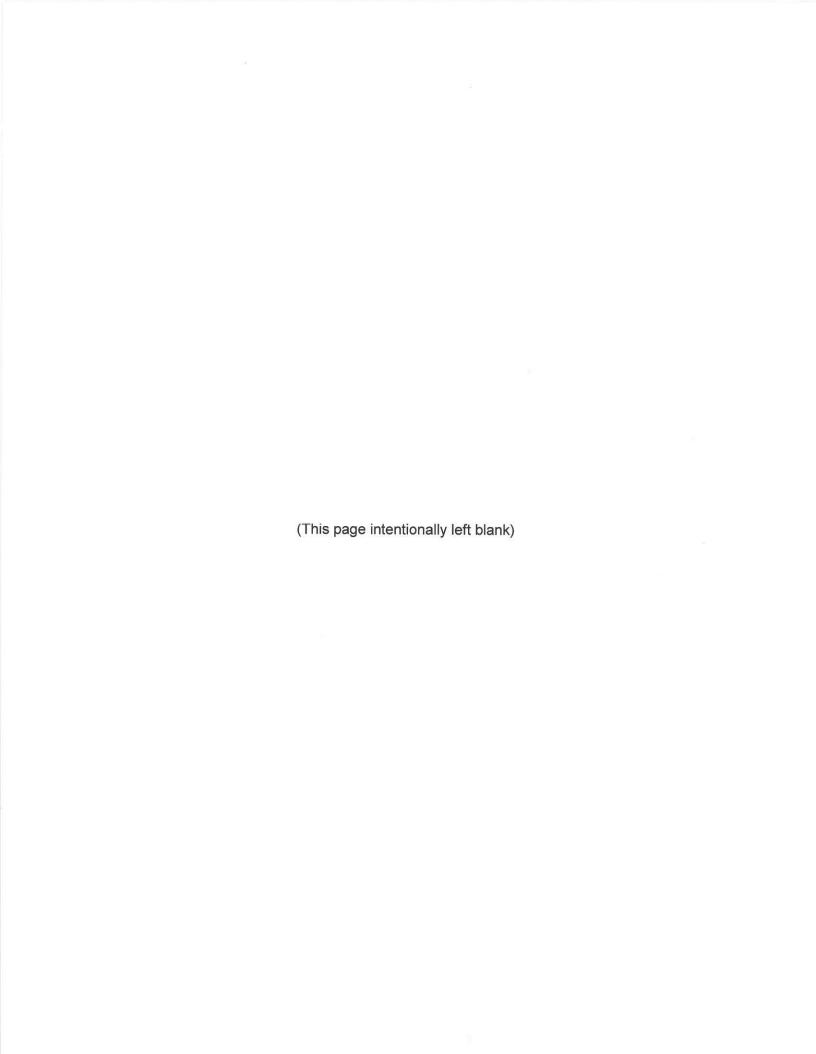
