## PROPOSITION 1 FUNDING SUMMARY

Proposition 1 (Assembly Bill 1471, Rendon) authorized \$7.545 billion in general obligation bonds for water projects including surface and groundwater storage, ecosystem and watershed protection and restoration, and drinking water protection. The State Water Resources Control Board (State Water Board) will administer Proposition 1 funds for five programs. The <u>estimated</u> implementation schedule for each is outlined in the table below.
