The purpose of this letter is to inform you of the process for renewal of California registration of water treatment device models for continued sale in California in calendar year 2018. We have enclosed an invoice with a list of the treatment device models that we understand you intend to register for 2018. To complete the registration of these models, please provide the following by May 18, 2018:

 Payment of the annual registration renewal fee of \$350 for each device model that you wish to register for 2018. Please <u>clearly identify</u> which models your payment covers. Payment must be sent via mail to the following address with an electronic copy of the check sent via email to <u>WTDevices@waterboards.ca.gov</u>.

- 2. List of any models that you wish to register that are not listed on the invoice and/or that you wish to voluntarily drop from the registration listing status, in case the model is no longer being marketed in California (use the forms attached).
- 3. Current Performance Data Sheet (PDS) in pdf format for each device model.

**IMPORTANT NOTE**: You must submit a current PDS for each device model to remain registered in California. These PDS will be posted along with our internet listing to provide the required consumer information in accordance with California statutes (<u>Health and Safety Code §116832</u>).

4. Verification of certification. This verification can be in pdf format or a screenshot of the certifying organization's internet listing of your device.
