## NOTICE OF PUBLIC AVAILABILITY OF CHANGES TO PROPOSED REGULATIONS REGARDING REVISION OF WATERWORKS STANDARDS (R-14-03)

Pursuant to Government Code Section 11346.8(c), notice is hereby given that the Department has changed the text of the proposed regulations regarding the Revision of Waterworks Standards (R-14-03) and is making the changed text available for public comment prior to adoption, amendment or repeal of the resulting regulations. A copy of the proposed text with the new changes clearly illustrated is attached.
