OPPORTUNITY FOR PUBLIC COMMENT AND PUBLIC WORKSHOP REGARDING CALIFORNIA ENVIRONMENTAL LABORATORY ACCREDITATION PROGRAM (ELAP) REGULATIONS DEVELOPMENT AND PRELIMINARY STAFF RECOMMENDATION FOR LABORATORY STANDARD

NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will receive public comments on the development of regulations for the California Environmental Laboratory Accreditation Program (ELAP) and the preliminary staff recommendation for the laboratory standard component of the regulations.

NOTICE IS ADDITIONALLY HEREBY GIVEN that the State Water Board will hold a public workshop to provide information and answer questions on the development of regulations for ELAP and the preliminary staff recommendation for the laboratory standard component of the regulations.

The workshop is an opportunity for interested persons to provide oral comments to the State Water Board Members. A quorum of the State Water Board Members may attend this workshop. This will be an informational workshop only and the State Water Board will not take any formal action at this meeting. Details of the workshop are provided below.

BACKGROUND

In August 2015, the State Water Board contracted with Southern California Coastal Water Research Project to establish and facilitate an Expert Review Panel to conduct an examination of ELAP. The Panel members are five experts in the field of environmental laboratory accreditation. The Expert Review Panel released a final report of findings on October 22, 2015, which was presented to the State Water Board by the panel chairperson at the Board Meeting on November 4, 2015. The State Water Board is seeking to improve ELAP by revising existing regulations to address the issues identified in the Expert Review Panel Report.

The Expert Review Panel concluded that ELAP's current regulations are inadequate. The Panel recommended the immediate selection of an appropriate assessment standard and recommended ELAP adopt an existing laboratory accreditation standard that incorporates a quality system approach. The Panel specifically identified the laboratory standard established by The NELAC Institute (TNI) as the most viable option. The NELAC Institute (TNI) is a 501(c)(3) non-profit organization whose mission is to foster the generation of environmental data of known and documented quality through an open, inclusive, and transparent process that is responsive to the needs of the community.

Since release of the report, ELAP staff has engaged the stakeholder community and its two advisory bodies, the Environmental Laboratory Technical Advisory Committee (ELTAC) and the State Agency Partner Committee (SAPC), in its work to correct program deficiencies. After considering alternative options and with input from both committees and the larger stakeholder community, ELAP staff has made a preliminary determination to develop regulations incorporating the 2016 NELAC Institute (TNI) Standard, Volume 1: Management and Technical Requirements for Laboratories Performing Environmental Analysis as the laboratory standard. ELAP will consider revisions to portions of the standard that may be problematic for implementation in California before the formal rulemaking process commences. Once the regulations are proposed for adoption, a public comment period will be held as provided in the Administrative Procedure Act.

Compliance with the new standard may require some currently accredited laboratories to implement new laboratory management procedures or begin documenting procedures already in place. ELAP staff will provide a suite of implementation tools to assist the laboratory community with the transition if the TNI standards are adopted into California regulations. In addition, ELAP staff has made a preliminary determination to recommend to the State Water Board that the regulations allow extended time from the date of adoption for laboratories to meet any new laboratory standard requirements.

The 2016 TNI Standard is copyrighted, and generally must be purchased from TNI. However, in order for interested persons to provide comment on the proposed standard, the 2016 TNI Standard is being made available for evaluation:

The laboratory will be required to attest that the document will not be reproduced following the comment period while in their possession. Failure to abide by the requirement to not reproduce the document could result in penalties for copyright infringement.
