On February 20, 2024, the State Water Resources Control Board's Environmental Laboratory Accreditation Program (ELAP) sent you a Notice of Immediate Suspension of ELAP Certificate 3092 ("the Notice"). We write to correct a typographical error on page four of the Notice. The effective date of the suspension of ELAP Certificate is 3092 is **February 20, 2024**, the same date as the Notice. The Notice delivered to you contains an error on page four which identifies February 16, 2024, as the effective date. We regret the error.

An updated version of the Notice that corrects this error is attached. Please note that the 20-day period to request a hearing under Health & Safety Code section 100915 shall run from the date of this letter, *i.e.*, any request for a hearing under Section 100915 shall be submitted within 20 days from the date on which this letter is received.
