The State Water Resources Control Board will hold a series of community workshops to explore and evaluate potential long-term drinking water solutions and governing options for a sustainable regional approach to serve the seven neighboring communities of **Cutler, East Orosi, Monson, Orosi, Seville, Sultana, and Yettem**.

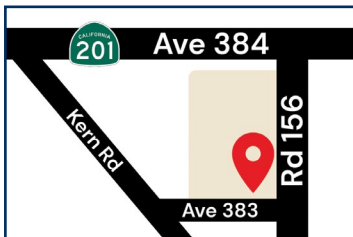

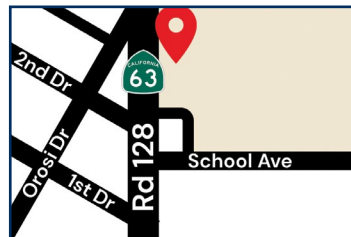

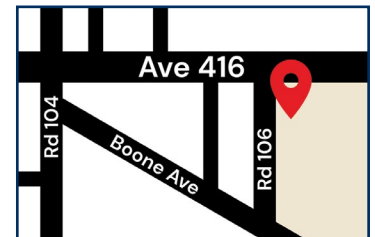

# NORTHERN TULARE COUNTY REGIONAL DRINKING WATER SOLUTIONS PROJECT

## PROJECT BACKGROUND

The goals of the Northern Tulare County Regional Drinking Water Solutions Project workshop series are:

- Learn about the drinking water needs and concerns of each community and begin to develop a shared regional vision.
- Review draft feasibility study results showing possible drinking water solutions and their estimated costs.
- Identify potential regional drinking water solutions that could reliably serve East Orosi, Orosi, Cutler, Monson, Sultana, Yetttem, and Seville.
- Learn about different regional governance structures and discuss which model could work best for the communities.
- Gain clarity on the State Water Board's funding process, including how projects are evaluated and what funding options are available.
- Identify clear next steps to move forward with a regional drinking water solution.

## SAFER PROGRAM INFORMATION

This meeting is part of the Safe and Affordable Funding for Equity and Resilience (SAFER) Drinking Water Program. The SAFER program was designed to ensure Californians who lack safe and affordable drinking water receive it as quickly as possible. The SAFER program helps water systems achieve this goal through a set of tools, funding sources, community engagement, and regulatory authorities.
