BACKGROUND

The goals of the North Tulare County Regional Water Solutions workshop series are:

- Identify community needs and understand concerns that exist specific to each community.
- Understand and identify feasible regional drinking water solutions to affordably and reliably serve drinking water to East Orosi, Orosi, Cutler, Monson, Sultana, Yettem, and Seville.
- Understand and discuss governance structures for a regional water solution and work to agree upon a single governance structure that would oversee a regional water solution.
- Identify concrete next steps to initiate a regional drinking water solution and discuss how to develop a strong funding application.

At the first meeting of this series, we will:

1. Introduce the regional water solutions project
2. Introduce the regional feasibility study currently underway, and a high-level overview of potential solutions being evaluated
3. Introduce potential governance structures in the case that a regional water solution is feasible, and
4. Discuss community goals for a regional water solution.
