Summary of Activity #1

Community Challenges:

- Unsafe drinking water
- High service costs and reliance on bottled water
- Aging infrastructure and limited governance capacity
- Lack of community engagement

Goals for Regionalization:


- Lower costs, better infrastructure, fair representation, and long-term sustainability and collaboration

Summary of Activity #2

Despite differences in the models, several shared concerns and priorities emerged:



- Fair and balanced representation, especially for smaller underserved communities




Exit Ticket Results





Selected Project Alternative

- Each water system shall submit its preferred infrastructure alternative from among those presented in the feasibility study completed by Provost & Pritchard Consulting Group to DDW by **December 19th**.
 - Alternative 1: Individual System Improvements and Physical Consolidation Loop
 - Alternative 2: Regional Surface Water Treatment Plant Partial Supply
 - Alternative 3: Regional Surface Water Treatment Plant

Joint Governance Term Sheet

- Draft a governance term sheet jointly among all participating water systems and submit to DDW by **December 19th**
 - The proposed governance model to be pursued
 - The preliminary structure for board representation and decision-making
 - A general timeline and next steps for implementation
 - Points of agreement and areas still under discussion
- The purpose of the Governance Term Sheet is to ensure mutual understanding, build alignment, and establish a path forward as the water systems move toward formal consolidation.

Why now?

- Funds are finite and demand is high.
- The State Water Board is **currently funding** Technical Assistance to support this regionalization project.
- The Planning Technical Assistance funding for regionalization may not be available in the future.
