BACKGROUND

The State Water Board is implementing the Safe and Affordable Funding for Equity and Resilience (SAFER) Drinking Water Program with a set of tools, funding sources, and regulatory authorities designed to ensure that the approximately one million Californians who currently lack safe drinking water receive safe and affordable drinking water as soon as possible.

The SAFER Program is responsible for conducting an annual Needs Assessment, which consists of three components: (1) Affordability Assessment; (2) Risk Assessment (3) Cost Assessment. Results of the Needs Assessment are used to inform the prioritization of projects in the annual Fund Expenditure Plan for the Safe and Affordable Drinking Water Fund.

The State Water Board's Needs Analysis Unit in the Division of Drinking Water is leading the implementation of the Needs Assessment in coordination with the Division of Water Quality (DWQ) and Division of Financial Assistance (DFA). The University of California, Los Angeles (UCLA) was contracted (agreement term: 09.01.2019 through 03.31.2021) to support the initial development of Needs Assessment methodologies for the Risk Assessment and Cost Assessment.

On <u>April 17, 2020</u> the State Water Board hosted its first webinar workshop on Identifying At-Risk Water Systems and Domestic Wells. Recommendations from the public lead to an expansion of risk indicatory categories to be considered for the Risk Assessment 2.0.

On <u>July 22, 2020</u> the State Water Board hosted the second webinar in this series, soliciting public feedback and recommendations on potential risk indicators and an evaluation methodology to assess the applicability and fitness of the identified potential risk indicators for inclusion in Version 2.0 of the Risk Assessment.

Part 3 Webinar Series: IDENTIFYING AT-RISK PUBLIC WATER SYSTEMS – SELECTING RISK INDICATORS

The State Water Board Division of Drinking Water Needs Analysis Unit, in partnership with the University of California, Los Angeles, is seeking stakeholder feedback and recommendations on a recommended set of risk indicators for inclusion in Version 2.0 of the Risk Assessment for public water systems. Version 1.0 of the Risk Assessment utilized 14 risk indicators. In response to public feedback, UCLA and the State Water Board identified nearly 120 potential risk indicators that may be used in Version 2.0 of the Risk Assessment to assess water quality, accessibility, affordability, and TMF (technical, managerial, and financial capacity). This effort includes risk indicators identified in complimentary efforts conducted by Office of Environmental Health Hazard Assessment and the Department of Water Resources.

The State Water Board and UCLA have utilized the Risk Indicator Evaluation Tool, summarized in the <u>July 2020 White Paper</u>, to assess the applicability and fitness of the identified potential risk indicators for inclusion in Version 2.0 of the Risk Assessment. This webinar will provide an overview of the results of this evaluation and a recommended set of final Risk Assessment 2.0 risk indicators for public feedback and consideration.
