1. The SFY 2025-26 Drinking Water State Revolving Fund (DWSRF) Intended Use Plan (IUP) states that the Deputy Director of DFA will have flexibility to fund systems that are not failing or at-risk of failing, if the Deputy Director of DFA determines the project will address a risk of failure.
2. Consolidation projects are eligible for grant/principal forgiveness (PF) funding for up to 100% of the project cost regardless of SAFER status.
