# NOTICE OF STAFF WORKSHOP ON PROPOSED REFINED WATERSHED ANALYSIS AND FRIANT PRIORITY DATE ADJUSTMENTS IN THE WATER UNAVAILABILITY METHODOLOGY FOR THE DELTA WATERSHED

State Water Resources Control Board (State Water Board or Board) staff will hold a technical workshop to receive public input on proposed changes to the Water Unavailability Methodology (Methodology) for the Delta Watershed, including a refined watershed-scale analysis and adjustments to the assumed priority dates for water rights associated with the Friant Division of the Central Valley Project. During the workshop, there will be a staff presentation followed by the opportunity for questions and comments.

During the workshop, staff will seek public input on the following topics related to the Water Unavailability Methodology:

- The Refined Watershed Analysis proposed changes to the Methodology that improve the spatial resolution of water unavailability analyses conducted for the Sacramento and San Joaquin River watersheds.
- Friant Division priority date adjustments proposed changes to the assumed priority dates of water rights held by the U.S. Bureau of Reclamation (Reclamation) for the Friant Division of the Central Valley Project.

#### BACKGROUND

The Delta watershed has been facing severe drought conditions starting in 2020. Following a dry year in 2020 and a critically dry year in 2021, the Delta is currently facing a third year of dry conditions in water year 2022. Continued dry conditions are expected to result in severe limitations in water supplies, including limited reservoir storage levels and associated water quality and environmental concerns.

On July 20, 2022, the State Water Board revised and renewed an emergency regulation authorizing the curtailment of diversions when water within the Delta watershed is determined to be unavailable at a water right holder's or claimant's priority of right. (Cal. Code Regs., tit. 23, §§ 876.1–879.3.) The regulation was approved by the Office of Administrative Law and went into effect upon filing with the Secretary of State on August 12, 2022. The emergency regulation will remain in effect for up to one year but could be repealed if hydrologic conditions improve or renewed again if drought conditions persist.

Curtailments are determined using the Water Unavailability Methodology, which evaluates water unavailability by comparing supplies and demands at the headwater subwatershed and Sacramento and San Joaquin River watershed scales in order of water right or claim priority. The proposed Refined Watershed Analysis improves the spatial resolution of the watershed analysis by distributing the demands of an individual water right or claim only among the tributaries upstream of its subwatershed. The Refined Watershed Analysis does not change the headwater subwatershed analysis or other aspects of the existing Methodology. A summary document describing the Refined Watershed Analysis and comparing its approach to the current Methodology is available on the Board's Water Unavailability Methodology webpage.

The proposed adjustments to the priority dates of Reclamation's water rights for the Friant Division are consistent with Reclamation's position that the Friant service area is within the watershed of origin, or an area immediately adjacent thereto which can conveniently be supplied with water therefrom, within the meaning of Water Code section 11460, and therefore Reclamation's rights associated with the Friant Division should not be considered junior to all other rights within the San Joaquin River watershed. Reclamation's position is supported by the U.S. Supreme Court's decision in *City of Fresno v. California* (1963) 372 U.S. 627. In the current Methodology, water rights A000023, A000234, A001465, and A005638 (License 1986, and Permits 11885, 11886, and 11887, respectively) are all assumed to have "Project" priorities that make them the most junior rights in the watershed due to area of origin protections. With the proposed adjustments, the priority dates of these rights would be changed to March 27, 1915; January 19, 1916; September 26, 1919; and July 30, 1927, respectively, to reflect the dates when the underlying applications to appropriate water were filed.
