The manager will send the logs and photos to the Water Board around the first of each month."

We would like to be exempted from photos + daily records as we have flow meters on the pivots and the RCD as the coordinating entity will come and read the flow meters ~~and~~ once a month and we will supply him with the wheel line + pods records. We do not irrigate daily. All our fields have different water needs.

- **Scott River Watershed:** A net groundwater pumping reduction of 30% throughout the irrigation season (April 1 – October 31) and a monthly reduction of 30% between July 1 through October 31.
- **Shasta River Watershed:** A net groundwater pumping reduction of 15% throughout the irrigation season (March 1 – November 1) and a monthly reduction of 15% between June 1 through September 30.
- The relevant water use reduction shall be based on a comparison to a baseline irrigation season (i.e., 2020, 2021, 2022, or 2023).
  - BUT, if the previous year baseline is higher than the following applied water rates:
    - 33 inches per year for alfalfa,
    - 14 inches per year for grain, or
    - 30 inches per year for pasture
  - ❖ Then the above values shall be used as the baseline UNLESS the applicant provides sufficient additional information supporting an alternative baseline.

Proposal for groundwater percent reduction of  
Groundwater:

Because we had such a good spring we irrigated much less than usual so we were already approximately 60% reduced from 2020 through July and quit watering when the curtailment began after Shelly Fire warnings lifted. So I'm proposing putting down not more than 20 acre ft. which would still have us at least 40% reduced from 2020. We probably would be putting less than that and a lot depends on weather. We also will not water in Oct. unless we are still under 20 acre ft.


