

Lauren,

The General Order for Composting Operations specifies Biosolids (A, B, and/or EQ) can be accepted at a Tier II facility; Nursery Products does accept some Sub-Class B biosolids at their facility. Per the General Order, the Executive Officer can allow a feedstock not specified in the General Order to be accepted at a Facility if site conditions allow. This facility was constructed in accordance with the requirements of California Code of Regulations, title 27, which are more restrictive than what is specified in the construction requirements of the General Order. Additionally, Nursery Products will continue to monitor the groundwater for coliform (in addition to other constituents). Therefore, given the site conditions, we feel it is appropriate to allow this particular group of biosolids to be composted at the facility.

Does the SWRCB General Permit for composting currently not allow composters covered under it to take sub-Class B biosolids for composting? Nursery Products currently takes biosolids from a number of POTWs who have not achieved Class B pathogen reduction at the POTW, for then composting at Nursery Products to Class A pathogen reduction levels.
