#### 6. CITY OF VICTORVILLE SETTLEMENT AGREEMENT AND STIPULATION FOR ENTRY OF ADMINISTRATIVE CIVIL LIABILITY

Water Board staff, Scott Ferguson, Senior WRC Engineer, gave a presentation on background of the Administrative Civil Liability (ACL) Complaint; explained the Settlement Agreement terms; Water Board options, and asked the Water Board to consider acceptance and provide direction to the Executive Officer on a Settlement Agreement and Stipulation for Entry of Administrative Civil Liability to be entered into by the Water Board and the City of Victorville.

Mr. Ferguson explained that on Bates Stamp 6-74, paragraph C, there was a minor error in the last sentence. Mr. Ferguson indicated it should read "...fourth largest..." not "...third largest..."

Keith Metzler, General Manager, with the City of Victorville (City), thanked the Water Board staff for working with the City. Mr. Metzler explained the spill, the violations, how Victorville responded to the spill, and indicated they will continue to work on fixing the problem.

#### COMMENTS BY THE WATER BOARD

Elizabeth Beryt, Chief Counsel, confirmed that the City agreed with Mr. Ferguson's change noted above.

Member Sandel asked why the compliance report was not done by the Water Board. Mr. Ferguson indicated Water Board initiated the investigation and Water Board staff reached out to State Water Board for their direction and guidance. State Water Board does a more indepth Report and therefore, was the best decision.

Member Dyas indicated the SEP chosen for this process is a good one and asked if Water Board had previously monitored the wells to see what it looked like before the discharge. Mr. Ferguson indicated Water Board did not monitor the wells and therefore, does not know what the appearance of the wells were pre-discharge. Dr. Horne stated there are several incidents discovered and the percentage of discharge collection was small. Mr. Ferguson reiterated that the discharge occurred for a time before it was discovered. Once the discharge was discovered Water Board and City worked together to take the steps necessary to take care of it.

<u>Motion</u>: Moved by Member Dyas, seconded by Member Jardine, to accept the Settlement Agreement and Stipulation for Entry of Administrative Civil Liability to be entered into by the Lahontan Water Board and the City of Victorville with the change to Bates Stamp 6-74 (page 50 of the Attachment A Administrative Civil Liability Methodology") paragraph C, last paragraph to change the word "third" to the word "fourth".
