BACKGROUND

The Lahontan Water Board staff spent considerable time in 2021 developing a Strategic Narrative, in part, to create a framework across the entire organization to help determine how to best allocate staff resources while meeting agency mandates, missions, vision, values, and goals. This Strategic Narrative starts at a high level with organizational mission, vision, values and goals and then tiered to a division level and then down to specific units with declared objectives on a 1-3 year timeframe. For the Forest Activities Program, the Divisional Objective is to Develop a Region 6 Forest Program Strategy. This will be achieved partly by maintain the status quo while focusing on alignment with changing policies, processes, and permitting at the State Water Board and the CA Board of Forestry, as both agencies adjust to state and federal level mandates to increase the pace and scale of forest treatments to address the wildfire threat within California.

Focus of Effort priority tasks associated with the Forest Activities Program Divisonal Objective also include:

- help new staff understand the program objectives
- train new staff
- continue to create a field presence through inspections
- gather input from the regulated community and stakeholders to inform program evolution as the current Timber Waiver
- develop an updated Timber Waiver fact sheet

BACKGROUND

 Monitor legislative actions, and address 2021 wildfire season impacts. A final element of the Unit's focus of effort is to present this informational item to the Water Board.

The Timber Waiver is the permitting tool to regulate commercial and non-commercial forest management activities on public and private lands within the region. The Timber Waiver has been refined over the years and is generally well received by project proponents. The current Timber Waiver will remain in effect into spring of 2024. Staff are contemplating updating the Timber Waiver to General Waste Discharge Requirements before the current waiver expires but are watching developments in the legislature and at partner agencies to ensure that the revised forest management permit complements statutes and other agency requirements. The current Timber Waiver is a viable permit mechanism to allow for commercial logging, pro-active forest management, and emergency actions in a post-wildfire environment, whether those actions are commercial or non-commercial in nature, on both public and private lands.

Climate change, and past forest management practices have resulted in a dire wildfire threat across the state. There is an acknowledged need and desire for an increase in pace and scale of treatments to address wildfire threat and post-wildfire restoration. Water Board staff are engaged with stakeholders, partner agencies, and the State Water Board to keep permitting efforts in line with forest management needs and direction. The Lahontan Forest Activities Program staff also coordinate with the State Water Board to assist in the development of statewide permitting mechanisms related to forest management for small landowners and utility corridor treatments.

The Forest Activities Program, housed in the Forestry/Dredge and Fill Unit, has had significant staff turnover in the last two years. The late 2019 office re-organization and subsequent new hiring, coupled with promotions, retirements, and re-assignments has resulted in a 160% turnover in program staffing. Despite the challenges associated with staffing, the program has consistently met its performance targets for inspections of proposed, active, and completed projects. Monitoring and Reporting Program compliance is also high, with minor late reporting issues being addressed in a timely manner.

The forestry program has 5.5 PYs funded through the General Fund, AB 1492 (2012) and SB 901 (2018) allocations. AB 1492 waived permitting fees for commercial timber harvesting permits in CA while mandating a 1% fee on the retail sale of milled lumber in CA. This revenue funds forestry regulation across multiple CA regulatory agencies and also provides grant funds for forestry restoration activities, partly overseen by the Water Board's 319 (h) grant program.

There have been a number of wildfires within the Lahontan region over the years, but 2021 has seen historically significant fires. The Tamarack, Beckwourth, Dixie, and Caldor fires have all burned large areas within the region. Staff have engaged with USFS, BLM, CalFire, industrial timberland owners, fire protection districts, and small private forest land owners to facilitate pre- and post-fire response actions.

ISSUES

Key issues that the Forest Activities Program face are internal and external agency turnover, evolving statutory and partner agency regulatory changes, climate change and drought increasing wildfire threat. The economic and social impacts of the wildfire threat in California is increasing faster than policy or management actions are able to keep up with. Facing a multitude of issues and challenges in the Forest Activities Program, a key question that program managers and staff are faced with is how to create a Forest Program Strategy that effectively and efficiently use staff resources, while meeting both state and federal mandates in this ever changing political and environmental landscape.

The immediate answer to these challenges is to maintain a permitting mechanism for timber harvest and forest health treatments to proceed in a manner that is viable and also protective of water quality. Program staff believe that the current Timber Waiver is such a permit that meets this immediate need. Staff are engaging with the State Water Board, external stakeholders, and with partner agency personnel to determine which elements of the Timber Waiver should be modified/updated to better allow a desired increase in pace and scale, while also meeting agency mandates to protect water quality.

DISCUSSION

The purpose of this item is to update the Board on both current and evolving, internal and external issues/challenges facing the Forest Activities Program and a proposed Forest Program Strategy to directly address those same issues/challenges.

Staff will expand on the issues presented above and how the Forest Program Strategy that will be developed will help to address identified issues and challenges in the program. Input and feedback from the Board members and members of the public is welcomed.





State Water Board Permit Development: Vegetation Treatment General Order

- State Water Board Order No. WQ 2021-0026-DWQ
 - · Applies to noncommercial projects only, excludes federal land
- Forestry staff participated in permit development efforts
- Eligibility: projects analyzed using the California Vegetation Treatment Program Environmental Impact Report (CALVTP)
- Automatic enrollment by State Board, no action at Regional Boards



Senate Bill 901: Wildfires

- Approved September 21, 2018
- Initiated in the aftermath of the 2017 Sonoma County wildfires
- Directs CA regulatory agencies to synchronize forest management permitting and to address utility corridor wildfire threats
- Provided 3 positions to Lahontan Water Board in January 2020

Utility Corridor Management

- Staff review CAL FIRE issued Utility Corridor Right-of-Way Exemption Notices
- State Water Board permit development: Utility Right-of-Way General Order (ongoing)

Federal NPS Permit Update

- Overview of proposed Federal Nonpoint Source Permit:
 - Development of WDRs to regulate nonpoint source discharges for certain land management activities conducted by the United States Forest Service and Bureau of Land Management
 - · Collaborative effort with Central Valley Water Board staff
- Executive decision to withdraw staff resources (August 6, 2021)
 - Line-of-sight matrix used to support decision
 - · Partner, tribal, contractor notification
 - · Continued commitment to address NPS pollution

2014 Timber Waiver to General WDR

- 2019 renewal of 2014 Timber Waiver will expire in 2024
- Opportunity to pursue WDR, rather than a Waiver of WDR
 - No need to dedicate staff resources to 5 year renewal of conditional waiver
 - Stakeholder feedback is that TW is user friendly and effective
