3. REPORTS BY WATER BOARD CHAIR AND WATER BOARD MEMBERS

State Board member, Sean Maguire, gave updates to the Water Board. Including current drought updates. Workshop was held in February regarding Mercury in the waters.

4. USGS Background Study and PG&E Hinkley Annual Update. Report out on the United States Geological Survey (USGS) Results of the Hexavalent Chromium (Cr[VI]) Background Study, Hinkley, California.

Water Board staff, Amanda Lopez, Engineering Geologist, provided the Water Board with a summary of the history and development of the USGS Background Study. Dr. John Izbicki provided a high-level overview of the USGS's Chromium Background Study. Ms. Lopez also provided a brief timeline of the next steps for the project. Contemplated next steps include allowing the public and Water Board members time to review the report and providing another opportunity for the public to ask Dr. Izbicki questions at a future Water Board Meeting in 2023.

Ms. Lopez indicated in August 2023 Dr. Izbicki will return to answer questions about the background study. The Lahontan Water Board staff will provide more detail on incorporating the background study into the revised CAO, and provide a progress update on the CAO revision.

Once Water Board staff has an update, they will provide that to the Water Board.

7. *Rescission of Board Order No. R6V-2009-0035 Master Water Recycling Requirements and Waste Discharge Requirements for Mammoth Community Water District (MCWD) Disinfected Tertiary Recycled Water.

Water Board staff, John Yu, Water Resource Control Engineer, asked the Water Board to consider rescinding the master water recycling requirements (WRRs), so MCWD could become an Administrator of recycled water under State Water Resources Control Board Order WQ 2016-0068-DDW, *Water Reclamation Requirements for Recycled Water Use* (General Order) upon issuance of a Notice of Applicability for the General Order.

Mr. Garrett Higerd, District Engineer with the Mammoth Community Water District indicated he was available if anyone had questions regarding this General Order. No staff or public expressed that they had questions.
