REVISED NOTICE OF CONTINUED PUBLIC HEARING

Consideration of Amended Cease and Desist Orders No. R6V-2004-0038-A01 and R6V-2004-0039-A01 for

County Sanitation District No. 14 of Los Angeles County, and County Sanitation District No. 20 of Los Angeles County, respectively

NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board, Lahontan Region (Water Board), will hold a public hearing during its regular meeting on November 29, 2007, at the Lancaster City Council Chambers, 44933 Fern Avenue, Lancaster, CA 93534, to consider amending Cease and Desist Orders No. R6V-2004-0038-A01 and R6V-2004-0039-A01 for County Sanitation District No. 14 of Los Angeles County, and County Sanitation District No. 20 of Los Angeles County, respectively. At the May 23-24, 2007 Board Meeting, the Lahontan Water Board did not accept a proposed settlement of the Parties (Lahontan Water Board Prosecution Team and Los Angeles Community Sanitation Districts No. 14 and No. 20) which included the adoption of the cease and desist orders noted above, and directed the Parties to bring back a revised settlement proposal for consideration. This hearing is a continuation of the public hearing held during the March 14-15, 2007 Board Meeting and May 23-24, 2007 Board Meeting concerning these items. The Water Board Prosecution Team and District 14 and District 20 have reached a revised settlement in response to petitions for Writ of Mandate filed by the two Districts in Superior Court and direction provided by the Lahontan Water Board at the May 23-24 Board Meeting. The petitions challenged the two cease and desist orders listed above. The proposed revised settlement includes the amendment of the compliance schedules in the orders subject to the petitions.

This continued public hearing is intended to provide the Parties and the public the opportunity to comment on the proposed amendments. Interested persons are invited to attend and comment on this issue at this meeting. The deadline for written public comment expires November 19, 2007 at 5:00 p.m. Persons making presentations should confine statements to the issues pertinent to this hearing only. Oral testimony should be brief and may be limited by the Water Board Chair to allow all interested persons time to be heard.

At this meeting, the Water Board will affirm or reject the proposed amendments. Because these amendments are part of a settlement package, the parties to the settlement must agree with any modification. If the parties do not agree with the changes, the proposed amended orders will be withdrawn from consideration at this meeting.
