NOTICE OF OPPORTUNITY TO COMMENT

PROPOSED APPROVAL OF AMENDMENTS TO THE WATER QUALITY CONTROL PLAN FOR THE LAHONTAN REGION CLARIFYING THE ANTIDegradation Policy, Adding Mixing Zone Provisions, Revising Certain Waste Discharge Prohibitions, and Amending Chapter 5- Water Quality Control Measures for the Lake Tahoe Basin

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of the California Regional Water Quality Control Board, Lahontan Region's (Lahontan Water Board) amendments to the Water Quality Control Plan for the Lahontan Region (Basin Plan). The Basin Plan amendments were adopted by the Lahontan Water Board on April 9, 2014 and are available for review at: http://www.waterboards.ca.gov/rwqcb6/water_issues/programs/basin_plan/2014bpa/ and at the Lahontan Water Board office at 2501 Lake Tahoe Blvd., South Lake Tahoe, CA 96150.

REQUEST NOTICE OF STATE WATER BOARD MEETINGS. The State Water Board will separately publish an agenda for the meeting at which it will consider adopting a resolution approving the Basin Plan amendments. Oral comments at the State Water Board meeting generally will be limited to a summary of the written comments submitted during the written comment period. Persons interested (including those who submit oral or written comments to the Lahontan Water Board and State Water Board) in receiving notice of the meeting at which the State Water Board will consider approving the Basin Plan amendment **must subscribe** to: http://www.waterboards.ca.gov/resources/email_subscriptions/reg6_subscribe.shtml and check the box for Basin Planning - Regionwide. The State Water Board encourages use of its electronic mailing list. Persons who require notice by regular mail must submit such request to the Lahontan Water Board contact identified above.

SUBMISSION OF WRITTEN COMMENTS. Persons interested in the Basin Plan amendments are encouraged to submit comments electronically. Comment letters **must be received by 12:00 noon on May 30, 2014**. Comment letters received after that deadline will not be accepted unless the State Water Board determines otherwise. REQUIREMENTS FOR SUBMITTING COMMENTS (23 Cal. Code Regs., §3779, subd. (f)).
The State Water Board may refuse to accept any comments that do not satisfy all of the following requirements:

1. Comments must specifically address the final version of the Basin Plan amendments adopted by the Lahontan Water Board.
2. If the Lahontan Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Lahontan Water Board to each comment was inadequate or incorrect.
3. The commenter also must include either a statement that each of the comments was timely raised before the Lahontan Water Board, or an explanation of why the commenter was unable to raise the specific comment before the Lahontan Water Board.
