NOTICE OF CEQA SCOPING MEETING

FOR A BASIN PLAN AMENDMENT TO REVISE SITE-SPECIFIC OBJECTIVES FOR TOTAL NITROGEN AND NITRATE IN HOT CREEK, MONO COUNTY

NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board, Lahontan Region (Lahontan Water Board) will hold a California Environmental Quality Act (CEQA) scoping meeting at the following time and location:

The Hot Creek Nitrogen Site-Specific Objectives Project involves developing a proposed amendment to the Water Quality Control Plan for the Lahontan Region (Lahontan Basin Plan) which would revise the total nitrogen and nitrate as N water quality objectives for Hot Creek and move the location along Hot Creek at which these objectives apply. The proposed amendment could result in less stringent nitrogen water quality objectives to account for the unique ecological condition of Hot Creek that supports abundant aquatic life as well as rare and threatened species.

State regulations require that Basin Plan amendments that are “projects” for purposes of CEQA, be accompanied by substitute environmental documentation (SED) (23 CCR § 3775-3781). The purpose of the scoping meeting is to provide a forum for the public to provide input on the scope and content of the environmental analysis included in the draft SED that will be prepared to support the proposed Basin Plan amendment. Scoping is helpful to the Lahontan Water Board in identifying the range of actions, alternatives, mitigation measures, and significant environmental effects to be analyzed in the SED. The meeting will consist of a presentation regarding the proposed changes to the Basin Plan, and an opportunity for meeting participants to provide input about the content of the environmental analysis to be included in the draft SED.

Lahontan Water Board staff will not prepare written responses to each individual comment received but will incorporate written responses to all significant environmental points in the report that will be publicly available for review and comment on the Lahontan Water Board website.
