Peter – Thank you for sending the revised Los Angeles County LAMP and Scott Abbott's April 20, 2018 letter.

Region 6 appreciates Los Angeles County proposing a compromise alternative, suggesting to require collecting periodic effluent samples from advanced treatment systems in the Antelope Valley at commercial facilities, but not from single family residences.

We can accept this, but request that the definition of "commercial" facilities be expanded to include institutional facilities such as schools, churches, and facilities with flows larger than one equivalent dwelling unit (EDU) where one EDU equals 250 gal/day.

The revised LMAP indicates that quarterly effluent samples would be collected from advanced treatment systems within the Tier 3 impaired water body areas. For the Antelope Valley, periodic annual effluent samples would be acceptable. The results of those samples should be included in the Annual Reports, along with a summary of any enforcement compliance actions taken by the county.

We would like to review any proposed language to this effect.
