**REQUEST FOR PUBLIC COMMENT**

**DRAFT CHANGES TO THE  
LAHONTAN REGIONAL WATER QUALITY CONTROL BOARD'S  
TIMBER HARVEST AND VEGETATION MANAGEMENT REGULATORY  
DOCUMENT**

**NOTICE IS HEREBY GIVEN** that staff of the Lahontan Regional Water Quality Control Board (Water Board) is requesting public comment on draft changes to our timber harvest and vegetation management regulatory document. The Water Board is the California state agency responsible for water quality protection from the Oregon border to the northern Mojave Desert east of the Sierra Nevada crest.

**NEED FOR REVISIONS**

The Water Board's current timber harvest regulatory document is a conditional waiver of waste discharge requirements (the 2014 Timber Waiver, Board Order No. R6T-2014-0030) to regulate waste discharges resulting from timber harvest and fuel reduction projects. The 2014 Timber Waiver applies to vegetation management projects that range from homeowner defensible space operations to local Fire Protection Districts' community protection plans, to large Wildland Urban Interface projects proposed by the California Department of Parks and Recreation, the Bureau of Land Management, and the US Forest Service (USFS). Commercial timber harvest conducted by small landowners, industrial timber companies, and the USFS are also covered under Timber Waiver categories. The 2014 Timber Waiver expires in April 2019. In California, all waivers of waste discharge requirements are limited to five years in duration, after which they must be renewed or replaced (California Water Code section 13269(a)(2)).

Due to the increased severity of wildfires in California, regulatory and policy changes are being contemplated by the California legislature to allow a more streamlined approach to forest management and fuels reduction projects. For example, Senate Bill (SB) 901 is a broad package of proposed legislation to address multiple aspects of wildfire prevention and recovery within California. Among its provisions, SB 901 would create two new timber harvesting exemptions within the Forest Practice Rules, including one which would allow for road building. In developing a revised timber harvest regulatory program, Water Board staff is contemplating ways to respond to such upcoming legislation to facilitate increasing the pace and scale of projects to improve forest resilience and mitigate mounting wildfire risk worsened by climate change, while protecting and maintaining water quality.

## CONTEMPLATED CHANGES TO TIMBER WAIVER

Change the Timber Waiver to General Waste Discharge Requirements. By changing the conditional waiver to general waste discharge requirements (WDR), there will no longer be a requirement to renew the regulatory document every five years. Removing the need to renew the Timber Waiver every five years would allow our staff and implementing agency staff to focus on more important tasks, such as field inspections to ensure water quality is being protected, and working directly with stakeholders in planning for increased pace and of scale projects. The WDR is anticipated to have a similar structure as the 2014 Timber Waiver with different tiers of projects types ranging from Category 1 of no to low water quality threat up to Category 6 for the highest water quality threat. The Water Board has the discretion to reopen the WDR and make changes if needed anytime.

Streamline and Simplify Regulatory Processes. Water Board staff are considering revising categorical notification, application, and monitoring requirements to simplify permitting. A new category may be added to streamline permitting for vegetation management activities associated with utility corridors and infrastructure.

Clarify Requirements for Non-Industrial Timber Management Plans (NTMPs). The 2014 Timber Waiver includes categorical requirements for enrolling NTMPs. To comply with requirements under SB 901 (if the SB is passed), additional clarification on enrollment processes and requirements for NTMPs would be needed in the timber harvest regulatory document to allow multiple landowners to operate under one plan.

Water Board staff would like your comments on these potential changes, and would appreciate comments on other changes you wish to see to our timber harvest regulatory document.
