# NOTICE OF PUBLIC HEARING

# TO CONSIDER ADOPTION OF PROPOSED AMENDMENTS TO WATER QUALITY PETITION REGULATIONS

**NOTICE IS HEREBY GIVEN** that the State Water Resources Control Board (State Water Board) will hold a public hearing to receive comments on proposed amendments to regulations governing review by the State Water Board of action or failure to act by regional water quality control boards.

The State Water Board may adopt the proposed amendments at the end of the hearing. The location and time of the public hearing is provided below.

#### **BACKGROUND**

Water Code section 13320 provides that within 30 days of a regional water board's action or failure to act under specified sections of the Water Code, an aggrieved person may petition the State Water Board to review that action or failure to act. Existing regulations provide that a petition will be deemed dismissed by operation of law unless the State Water Board acts on a petition within 270 days of mailing a notification that interested persons have 30 days to file responses to the petition and the regional water board has 30 days to file the administrative record and a response to the petition. However, neither the Water Code nor the State Water Board regulations specify how long the State Water Board may take to determine whether to mail the notification. The proposed amendments will specify that the State Water Board must either mail the notification within 90 days of receipt of the petition, or the petition will be deemed dismissed by operation of law unless the petition is being held in abeyance.

For petitions received by the State Water Board before the effective date of the proposed amendments that are not being held in abeyance and for which the State Water Board has not mailed the notification, the proposed amendments provide either 120 days, 240 days, or one year from the effective date of the proposed amendments to mail the notification, depending on when the State Water Board received the petition. If the State Water Board does not mail the notification within the 120 day, 240 day, or one year period, the proposed amendments provide that the petition will be deemed dismissed by operation of law.

#### SUBMISSION OF COMMENTS

At the hearing the State Water Board will accept oral comments on the proposed amendments to the water quality petition regulations. Written comments will not be accepted. The deadline for submittal of written comments was April 30, 2014. The State Water Board received 12 comment letters. The State Water Board is not proposing to make any revisions to its proposed amendments in response to the comment letters.
