PROPOSED AMENDMENTS TO THE CALIFORNIA CODE OF REGULATIONS TITLE 23. WATERS. DIVISION 3. STATE WATER RESOURCES CONTROL BOARD. CHAPTER 6. RULES GOVERNING REVIEW BY STATE BOARD OF ACTION OR FAILURE TO ACT BY REGIONAL BOARD

Enclosed is a copy of the Notice of Proposed Rulemaking announcing Proposed Amendments to the California Code of Regulations, title 23, division 3, chapter 6. Chapter 6 governs the procedures under which the State Water Resources Control Board (State Water Board) may review a petition challenging an action or failure to act by a regional water quality control board.

You are invited to submit written comments relevant to the proposed regulatory action to the State Water Board. The written comment period closes at 5:00 p.m. on **April 30, 2014**. The State Water Board will only consider written comments received at the State Water Board offices by that time. All comments received will be considered and responded to in the Final Statement of Reasons.

The State Water Board has not scheduled a public hearing on the proposed action. However, interested parties may make a written request for a hearing no later than fifteen (15) days prior to the close of the written comment period.
