PROPOSED RELOCATION OF RECEIVING WATER STATION RSW-002D – COUNTY SANITATION DISTRICTS OF LOS ANGELES COUNTY, POMONA WATER RECLAMATION PLANT (NPDES NO. CA0053619, CI NO. 0755)

We received your email dated January 12, 2017, requesting approval to move the current location of receiving water station RSW-002D (also referred to as station R-C) to a new location that is 700 feet further downstream (depicted by the yellow arrow in the picture below). Your request explains that the channel generally has insufficient water flow at the current location, which presents a problem when trying to collect enough volume of water to conduct all of the required samples.



Your request for the relocation of receiving water sampling station RSW-002D is approved, since the proposed site has sufficient water for sample collection. Table E-1 under Section II (page E-5) of your Monitoring and Reporting Program (MRP), CI No. 0755, which lists the location of Receiving Water Station RSW-002D as, "San Jose Creek, downstream of Station RSW-001D (station R-C), Latitude N 34° 01' 8.6," Longitude W 117° 50' 27.7" is changed to read as follows:
