Dear Kevin Wahl,

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) staff transmitted letters dated April 16, 2025, and April 21, 2025, to the Camrosa Water District for the Camrosa Water Reclamation Facility containing (1) the tentative termination order for the WDRs and NPDES permit and (2) the tentative amendment order for the WDRs and WRRs permit, respectively.

In accordance with administrative procedures, the Los Angeles Water Board at a public hearing held on July 24, 2025, reviewed the tentative termination order and amendment, considered all the factors in the case, and adopted (1) WDRs and NPDES Termination Order No. R4-2025-0182 and (2) WDRs and WRRs amendment Order No. R4-2019-0118-A01.
