TERMINATION OF COVERAGE UNDER GENERAL WASTE DISCHARGE REQUIREMENTS – FORMER LA TERMINALS FACILITY, 560 PIER A PLACE, WILMINGTON, CALIFORNIA (ORDER NO. R4-2014-0187, FILE NO. 14-054, SERIES NO. 014, CI NO. 10060, GLOBAL ID WDR100017609)

Dear Mr. Harris:

On August 21, 2014, the California Regional Water Quality Control Board, Los Angeles Region (Regional Board) enrolled you under General Waste Discharge Requirements (General WDRs) Order No. R4-2007-0019 with a Monitoring and Reporting Program (MRP) CI No. 10060 for the injection of emulsified vegetable oil (Newman Zone) for groundwater remediation of halogenated volatile organic compounds (HVOCs) at the subject site.

On November 13, 2014, Mr. William Glenn, on behalf of Trihydro Corporation requested modification of the monitoring well list prescribed in the MRP CI No. 10060 to include well L-4 and well L-11 instead of well L-2 and well L-3 because wells L-2 and L-3 have a measurable thickness of light non-aqueous phase liquid (LNAPL) and cannot be used for monitoring purposes.

Upon the revision of the MRP, the Regional Board determined that the discharges met the conditions specified in General WDRs Order No. R4-2014-0187, *General Waste Discharge Requirements for In-Situ Groundwater Remediation and Groundwater Re-Injection*, adopted by this Regional Board on September 11, 2014.

On December 31, 2014, the Regional Board enrolled you under General WDRs Order No. R4-2014-0187 with a revised MRP CI No. 10060 for groundwater monitoring of the injection site.

In a letter June 30, 2015, you notified the Regional Board that you ceased injection of emulsified vegetable oil at the Former LA Terminals Facility was completed in October 2014, and requested termination of the WDR. All the monitoring events required in the MRP were completed; and no additional injections will be performed at the subject site.

Since the Former LA Terminals Facility has no plan to inject emulsified vegetable oil in the future, the coverage for the subject facility under Regional Board Order No. R4-2014-0187 is hereby terminated, with the exception of enforcement under the terms of the permit. However, a new WDR permit will be required when the remediation activity is resumed in the future.
