**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS—AZUSA LIGHT & WATER, 220 NORTH ASPAN AVENUE, AZUSA, CALIFORNIA (NPDES NO. CAG994006, CI-10239)**

Dear Ms. Barbosa:

The subject discharges are regulated under Order No. R4-2014-0141, General National Pollutant Discharge Elimination System and *Waste Discharge Requirements for Discharges of Groundwater from San Gabriel Valley Groundwater Basin to Surface Waters in Upper San Gabriel River and Rio Hondo Watersheds Los Angeles County*, adopted by this Board on July 10, 2014.

We have reviewed your February 4, 2019, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that you have completed the well testing project and that the General NPDES permit is no longer needed. Since there is no discharge of groundwater from the wells, coverage under Board Order R4-2014-0141, General NPDES Permit No. CAG994006, CI-10239 is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
