TRANSMITTAL OF THE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR EQUILON ENTERPRISES, LLC, MORMON ISLAND MARINE TERMINAL FACILITY, WILMINGTON, CA (NPDES NO. CA0003557, CI-1596)

Our letters dated April 4, 2011, and May 18, 2011, transmitted the tentative and revised tentative waste discharge requirements for renewal of your permit for the discharge of wastes under the National Pollutant Discharge Elimination System (NPDES) Program.

Pursuant to Division 7 of the California Water Code, this Regional Water Board at a public hearing held on June 2, 2011, reviewed the revised tentative requirements, considered all factors in the case, and adopted Order No. R4-2011-0097.

Order R4-2011-0097 serves as an NPDES permit, and it expires on May 10, 2016. Section 13376 of the California Water Code requires that an application/Report of Waste Discharge for a new permit must be filed at least 180 days before the expiration date.

You are required to implement the Monitoring and Reporting Program (MRP) on the effective date (July 2, 2011) of Order No. R4-2011-0097. Your first monitoring report for the period of July 2011 through September 2011, is due by November 15, 2011. Submit all monitoring and technical/progress reports to the Regional Water Board, ATTN: Information Technology Unit.

When submitting monitoring or technical reports to the Regional Water Board per these requirements, please include a reference to Compliance File CI-1596 and NPDES No. CA0003557, which will assure that the reports, are directed to the appropriate file and staff. Please do not combine your discharge monitoring reports with other reports, such as technical/progress reports. Submit each type of report as a separate document.


