

REVISED MONITORING AND REPORTING PROGRAM, GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS – DOMINGUEZ GAP BARRIER PROJECT, LONG BEACH, CALIFORNIA (NPDES NO. CAG994001, CI-6089)

Thank you for your letter dated July 18, 2002, requesting this Regional Board to amend your NPDES permit. You have requested the following changes:

- Add a new temporary discharge outfall located below Willow Street.
- Increase the flow rate of your discharge from 144,000 gallons per day (gpd) to 1.0 million gallons per day (mgd). This volume is necessary to fully develop and test the wells.
- Change Monitoring Reporting Program (MRP) to a new reporting schedule.

In our letter dated June 11, 1999, we authorized you to discharge groundwater generated from the maintenance of reinjection wells used to control seawater intrusion into the groundwater basin (the Dominguez Gap Barrier Project) in the Wilmington area under Order 97-045; General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in the Coastal Watersheds of Los Angeles and Ventura Counties, which also serves as your NPDES permit.

We have reviewed your request and have no objections to the changes noted above. In addition, we have made other modifications to your Monitoring and Reporting Program, including sampling collection requirements for terminating discharge if monitoring results indicate an exceedance, requirements for accelerated monitoring following the exceedance of an effluent limit, and have added a requirement for reporting the exceedance to the Regional Board.

Enclosed is your revised Monitoring and Reporting Program No. CI-6089. The discharge limits in Part E and Attachment B of Order No. 97-045 are applicable to your discharge. Discharge from your facility drains to Dominguez Channel and Los Angeles River (below Willow Street).

Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.

In order to avoid future annual fees, please submit written notification when the project has been completed and the permit is no longer needed.
