CONTINUATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS – OFFICE BUILDING, 10495 SANTA MONICA BOULEVARD, LOS ANGELES, CALIFORNIA (NPDES NO. CAG994004, CI-6740)

Dear Mr. Simons:

We have completed our review of your Notice of Intent (NOI) that you submitted for the abovereferenced facility for a continuation to discharge waste under the National Pollutant Discharge Elimination System (NPDES). Based on the information you have provided, the discharge at the subject facility meets the conditions specified in Order NPDES permit No. CAG994004, Order No. R4-2003-0111, General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by the Board on August 7, 2003.

Enclosed are your Waste Discharge Requirements, which also serve as your General NPDES permit, consisting of Order No. R4-2002-0111 and a revised Monitoring and Reporting Program No. CI-6740. Order No. R4-2003-0111 replaced Order No, 97-045, which has been terminated.

The discharge limitations in Part E.1.a. of Order No. R4-2003-0111 for the specific constituents listed in the table attached with the enclosed Fact Sheet are applicable to the discharge. The groundwater discharge from the site drains into Ballona Creek, therefore, the discharge limitations in Attachment B are not applicable to the discharge.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of coverage under this permit. All monitoring reports should be sent to the Regional Board, <u>ATTN: Information Technology Unit</u>. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-6740 and NPDES No. CAG994004", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.

In order to avoid future annual fees, please submit written notification when the project has been completed and the permit is no longer needed.

We are sending Board Order No. R4-2003-0111 only to the applicant. For those on the mailing list, please refer to the Board Order previously sent to you. A copy of the Order will be furnished
