REVISED GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS—PLAYA CAPITAL COMPANY—PLAYA VISTA SITE, 6775 CENTINELA AVENUE, LOS ANGELES, CALIFORNIA (NPDES NO. CAG914001, CI-6839)

In our letter dated September 17, 2007, we authorized the discharge of treated groundwater from the above-referenced facility under the National Pollutant Discharge Elimination System (NPDES) General Permit No. CAG914001, Order No. R4-2007-0022; *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Discharges Treated Groundwater From Investigation and/or Cleanup of Volatile Organic Compounds Contaminated-Sites to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on April 5, 2007.

We have received and reviewed your November 6, 2008, submittal requesting to modify your coverage under the general NPDES permit for the above-referenced project. The modification is necessary due to the rerouting of the treated groundwater discharge line through a recreational water feature which ultimately returns to the existing discharge point and receiving waterbody. We have no objections to you reusing the treated wastewater in your proposed Water Feature project under the condition that you implement additional monitoring of your effluent after it flows through the Water Feature.

Enclosed are your Waste Discharge Requirements, which also serve as your NPDES permit, consisting of Order R4-2007-0022, revised Fact Sheet, and Monitoring & Reporting Program No. CI-6839.

The revised Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of coverage under this permit. All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-6839 and NPDES No. CAG914001", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.
