GENERAL WASTE DISCHARGE REQUIREMENTS FOR SMALL COMMERCIAL AND MULTIFAMILY RESIDENTIAL SUBSURFACE SEWAGE DISPOSAL SYSTEMS – HOFFMANN-WOLYNEC LIMITED, LLC (MALIBU MEDIA CENTER), 22483 PACIFIC COAST HIGHWAY, MALIBU, CALIFORNIA (FILE NO. 90-050, ORDER NO. 91-022, MONITORING AND REPORTING PROGRAM NO. 7021)

On January 28, 1991, this Regional Board adopted Waste Discharge Requirements prescribed in Order No. 91-022 for the discharge of domestic wastewater at the subject facility.

The Malibu Media Center which is a commercial building occupying approximately 0.57 acre in the City of Malibu. Domestic wastewater from the facility is discharged to a septic disposal system consisting of a 1,200-gallon septic tank and approximately 550 square feet of leach lines. This system serves an estimate of 12 people working in the building.

As you may know, pursuant to the California Water Code, all waste discharge requirements are reviewed periodically, and, upon such review, may be revised by the Regional Board. Following a review of the existing requirements contained in Order No. 91-022, and inspection of the subject facility on June 11, 2002, Board staff has determined that the existing discharge meets the conditions specified in Order No. 01-031, "*General Waste Discharge Requirements for Small Commercial and Multifamily Residential Subsurface Sewage Disposal Systems*," adopted by this Regional Board on February 22, 2001. Please refer to the attached Fact Sheet. Therefore, your individual Waste Discharge Requirements Order No. 91-022 adopted on January 28, 1991, will be rescinded at a Board Meeting to be held on October 24, 2002, in the City of Simi Valley Council Chambers, 2929 Tapo Canyon Road, Simi Valley, California. Your enrollment under this General Waste Discharge Requirements Order No. R4-2002-0030 is effective on October 24, 2002.

Enclosed are your Waste Discharge Requirements, consisting of Order No. 01-031 and Monitoring and Reporting Program No. CI-7021. Your Monitoring and Reporting Program number (CI-7021) remains the same. Attached is the new Monitoring and Reporting Program.
